Stacy Road Update

The underground utility conflicts that have been preventing the construction of Stacy Road on the City of Allen side are finally resolved. With the amount of work left to be done; TxDOT believes all four lanes should be constructed and opened for travel in October. There will still be minor cleanup work and final items to finish beyond October, but the substantial completion should be done by then if the weather holds out.

CoServ gas came to the June 5 Town Council Meeting and explained what their issues were with the buried gas lines that were in conflict with TxDOT road construction and assured the town that these conflicts would be resolved by the end of June. They also committed to improved communication with Fairview going forward and assigned staff specifically to keep the town informed in situations like this and others that may arise. The council appreciated their willingness to come to the meeting and answer questions.



FIREWORKS PROHIBITION

As you continue having summer fun, please remember the use or possession of fireworks in the Town of Fairview is strictly prohibited. The Fairview Police Department enforces this prohibition, issuing citations for violations. Fireworks present hazards to the safety of residents and pets, as well as the natural beauty of the Town.

Many remember the fun and excitement of setting off fireworks as children; however, as parents and guardians, we must also consider the danger fireworks present to children's safety, in order to prevent injury.

Hot Texas summers make for extremely dry conditions, which creates a fire hazard for the Town. Whether a faulty firework ignites an immediate flame or a spent firework casing causes a delayed blaze, things can get out of control very fast, especially in the windy North Texas region. Every year across the nation, huge amounts of property are damaged by fire, all of which could have been prevented. UTILITY BILLING

Policies and Procedures

The utility billing department strives to keep residents up to date on its policies and procedures and in an effort to do so we are providing the following reminders about utility billing.

Utility rates are established through the budgeting process, approved by the City Council, and normally change on October 1. Rates can be viewed on the town website.

Utility bill payments may be made in a variety of ways

- Monthly ACH payments – the payments are automatically deducted from a customer's financial institution.
- Credit card payments can be made over the phone, in person at Town Hall or online via the Town website ([FairviewTexas.org/Utility Billing](http://FairviewTexas.org/UtilityBilling))
- Checks may be written and delivered via mail, the drop box outside of Town Hall or in person at Town Hall.

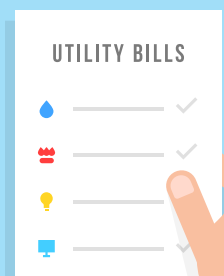
If you're moving you must notify the utility billing department at least two days before service is to be discontinued. A meter reading will be taken on the date requested and a final bill will be issued. If you're staying in Fairview and need to transfer your service you will still need to complete an application but your deposit will be waived as long as your account is in good standing.

Customers are responsible for all billings while the account is in their name. Account balances remaining after the specified monthly due date are subject to a 10 percent monthly penalty. Utility Billing makes courtesy phone calls reminding customers that the account is past due. Disconnect notices are mailed to customers whose accounts are more than thirty days past due and have a delinquent balance of \$25 or more. In the event of a disconnection a disconnect fee will be assessed to the account. Utility bills that are delinquent may be turned over to the Collin County Treasurer as property tax liens with an administrative fee added.

If your property has a water leak please contact the utility billing department as soon as you can. The Town of Fairview may provide financial assistance to repair leaks.

The Town of Fairview also offers a senior discount program. Residents 65 years or older may be eligible for a 20% discount. Just stop by Town Hall to pick up an application.

The Town of Fairview Utility Billing Department is located on the first floor of Town Hall, 372 Town Place. Business hours are Monday – Friday 8:00 a.m. – 4:30 p.m. You can contact the billing department staff via email at UtilityBilling@FairviewTexas.org or phone at 972-886-4242. Top Rankings for Lovejoy ISD

Lovejoy ISD continues to be ranked as one of the best districts, not only in the state but in the U.S. Lovejoy is an example of a district that provides an exemplary education to a group of students who are knowledgeable, talented and prepared for the future.

In May, *U.S. News and World Report* ranked Lovejoy High School in the top 1% of high schools in the nation. The district was also ranked #11 in NICHE's most recent ranking of Texas ISDs. And, Willow Springs Middle School is ranked 10th, out of more than 1,900 Texas Middle Schools by SchoolDigger.

The 2017/2018 school year has been filled with many successes for the district across the board. The Lovejoy High School visual arts program continued to have student's work selected to be a part of the Dallas Museum of Art Young Master's exhibit. 5G AND THEE!



Will 5G be faster than our current 4G Service?

Yes, it's faster. Comparing a 5G connection to an LTE 4G connection the 5G connection will be about 10 times faster. Speeds should range from 4 GB to 10 GB. It's like putting a turbocharger on your lawn mower. You'll be able to download an HD Movie in seconds!

When will 5G be available?

Major carriers; Sprint, Verizon, and AT&T are testing 5G right now. 5G to your home

Have you heard about 5G? It's the new upcoming wireless technology that's supposed to solve all our slow internet connectivity problems; including mobile phones and wireless Internet to the house. Below Bill Baxter, Town of Fairview IT Service provider will separate fact from fiction and what we might be able to expect in Fairview.

will be available before 5G for your cell phone. Some carriers will begin 5G rollout to homes by the end of the year. For mobile devices it will take longer maybe as late as 2020 because they are still working on the mobile 5G standards.

Will 5G be available for homes in Fairview?

Yes, but there are some limitations in regards to distance with the 5G signal. The signal only travels about a quarter mile. This means if a house is more than a quarter mile away from a utility pole on a road where a service provider might place their broadcast unit then 5G service won't be available until they figure out how to fix this limitation. Carriers are currently working on a solution for the "short distance issue" so stay tuned.

Will this be the next big thing in connectivity?

While it's fast and will connect all your devices one of the issues with 5G is the signal does not penetrate well through solid surfaces - yet. Testing has shown objects as thin as a leaf weaken the 5G signal. During the initial rollout expect to put your 5G router in a window.

Will 5G be used to broadcast TV signals?

Yes, AT&T is currently testing it's DirecTV Now video service over 5G in Austin.

Will users be required to purchase new equipment?

Yes, users will need to purchase a new router and once it's available for mobile devices you'll need to purchase devices that will connect to a 5G server.

"There are many people in Fairview who are patiently waiting for faster, cheaper, more reliable Internet service," says Baxter, "and, 5G will be the answer for some but not all of the residents, at first."

HEARD HAPPENINGS



Are you looking for something fun to do outside of the house – why not visit the Heard Museum? With day camps, nature hikes, a butterfly house and evening programs there is certainly something for everyone.

As the Heard prepares for the 13th anniversary of the Dinosaurs Live! exhibit, children ages 12 and under will have the opportunity to submit their own original artwork for a chance to have their artwork replicated through a custom paint job on one of this year’s exhibit dinosaurs—the Edmontonia. Submissions for the **Color-a-Dino Coloring Contest** are due no later than July 21. The winning artist and two runners-up will also receive prizes.

Did you know you can walk among free-flying native butterflies and other pollinators in the Heard’s **Native Texas Butterfly House & Garden**? The butterfly house includes native species, which vary by season and what is available from suppliers. The butterfly garden is filled with host plants that naturally attract these lovely creatures. You may even find a few ideas to try in your own garden! This exhibit is open through September 30 and is included in general admission and free for Heard Museum members.

The Heard also hosts weeklong **Summer Nature Camps**. They feature opportunities to delve into the wonders of nature on a 289-acre sanctuary, encounter animal ambassadors, investigate nature-themed topics, and more! Pre-registration is required. Specialty camps will offer opportunities to create art in nature, or even go behind-the-scenes to learn about animal care. Mini camps are also available.

The Heard will also host a **Shark Week Celebration** on July 22 from 1:30 – 4:30 p.m. Mick Tune of the Dallas Paleontological Society will offer talks (geared toward both kids and adults) about sharks, their fossils and how you can learn how to find your own. He’ll also talk about other residents of prehistoric oceans. This event is included in general admission and is free for Heard Museum members. More information about the day’s activities will be released soon.

Rounding out the month of July is **Magical Moth Night** on July 28 at 8 p.m. where guests can experience the magic of moths. These insects are often thought of as being less interesting than their popular lepidopteran cousins, butterflies. But on this night, the Heard will dispel this myth and show you the fascinating, flitting world of these winged beauties. Not only are they important pollinators, but they are also excellent indicators of the health of their natural environments. We’ll take a night hike out to the Native Texas Butterfly Garden and study moths firsthand through the use of non-lethal catch and release methods. The diversity of what we will find may come as surprise! Melanie Schuchart, one of our key entomology volunteers, will also lead an insightful talk about these amazing creatures. This event will also feature a new 4-foot diameter Magic Planet digital global display

as it illustrates the night sky in a whole new way. Light snacks will be available. Pre-registration is required. \$19/non-member; \$16/Heard Museum Members (Age 3 years through adult).

In addition to the Heard Natural Science Museum & Wildlife Sanctuary’s regular hours of operation, they will be open for general admission from 9 a.m. to 3 p.m. on July 9, 16, 23 and 30. Guests may not be admitted after 2 p.m. on these dates.

The History of Fairview

This is the third in a series of excerpts from the book, *Fairview, Texas: A brief History* by former Town Manager John Godwin.

George Apple took over the dairy in about 1924 when Sam moved back to McKinney. George also opened the Fairview Grocery on the southeast corner of SH 5 and FM 1378 across the road from the dairy. When the grocery started getting the dairy's checks by mistake, its name was changed to the Apple Dairy to eliminate the confusion. An historic photograph on display at town hall shows the grocery.

Cecil Apple used to train fighters in a barn on the Apple Farm in the early 1920s, apparently the same "old red barn" that remains there today. Sam Apple died in 1942 and his wife Emma in 1955. A source claims the dairy was forced to close when food laws required the pasteurization of milk and the dairy could not comply due to the unavailability of electricity. Members of the Apple family still live on the family land.

In 1958, as the City of McKinney threatened to annex the area, Robert Milligan (or Mulligan), a retired civil engineer, worked with George Apple to draw up and survey a plan and filed it with the Collin County Commissioners' Court requesting incorporation. Milligan had moved to the area to be near his kinsman, George Apple. When it came time to name the new community, both Fairview and Wetsel were considered, but the Fairview name was chosen to honor the by-then Colonel George Apple, who helped lead the incorporation process. According to original Fairview resident Lillie Mae Knight, "See, the old man, Mr. Sam Apple, was George Apple's father, and George, really, was the leader of getting this little town built, you see." Ironically Milligan's name does not appear on the petition requesting the incorporation election. The new town extended all the way east to include FM 1378, and the old Lick Springs area. Willie Hill owned much of the land and houses on 1378 there by Sloan Creek, and he ran a store by the creek.

About this same time, Fairview got a new church when on October 31, 1958 the Mount Olive Baptist Church purchased land from George Apple across the highway from his Fairview store and service station.

The first service at Mount Olive was held on June 21, 1959. The church was renamed First Baptist Church of Fairview in July 1965, and a new building built in 1986. The building today is the Good Seed Methodist Church, featuring Korean language services.

Bill Glover, Sr. was elected the first mayor of Fairview. Succeeding mayors included B. M. Stoddard, George Apple, Gary Olstrom, Orville Brown, Crim Watkins, Orla D. Brown, Walter Cross, Maarten Vet, E. Peter Haas (1978-82), Fred Carvajal, Leahray S. Wroten, Donald T. Phillips (1997-2003), and Sim Israeloff (2003 to the present). Apple was a noted auctioneer, and once served as Texas Chairman of Animal Health.

A water system was built in 1966, with water purchased from the nearby North Texas Municipal Water District, which then as now took much of its water supply from Lake Lavon. The NTMWD was itself created in 1951, while Lavon was still under construction. The original town water tower is no longer in service, but does still stand along the north side of Stacy Road in old Wetsel, a reminder of the town's past. The December 5, 1965 McKinney Courier-Gazette announced "Fairview Awards Water Contract," which describes awarding the bid for construction of the tower. Pittsburg DeMoines Steel was the low bidder at \$22,490 for the tank, and Olney Plumbing and Electrical submitted a low bid of \$100,776.10 for the distribution system. The system served a four-mile area in which there were 136 taps, according to Mayor George Apple. Financing of the project came from the Farmers Home Administration. The article also noted that in addition to Apple, the council included W. I. Hart, Earl Poston, Jerry Ahlstrom, H. H. Knight, and Bobby Watkins. The town secretary was Rosemary Lovell.

The Annual Summer Campaign of Allen Community Outreach to Prevent Hunger and Homelessness



According to the North Texas Food Bank (NTFB), 1 in 4 children in North Texas are food insecure, and on any given day they go to bed hungry. That is almost 300,000 children in our area. Allen Community Outreach's (ACO) Kids Summer Food Program provides more than 1,500 free bags of healthy, easy-to-prepare breakfast and lunch foods during the summer months for Collin County children whose household resources are limited.

Local residents rely on ACO's Kids Summer Food program. Last year, Erika, a mother of four, lost her job and was faced with many struggles. The most heart-wrenching was feeding her children. Her children range in age from 4 to 12 years old and have some major health issues, including a daughter with cerebral palsy and a son with autism. Having two children with special needs, Erika's challenges are real.

ACO was able to provide her family with bags of kid-friendly and healthy groceries all summer long and it helped relieve some of Erika's stress. Her cereal-loving 6 year old was happy with a few boxes to choose from each morning for breakfast. Her youngest two children thrived thanks to the fresh fruits they received in their bags. Lunches were just as easy with the items they received to prepare with favorites of all kids.

"ACO's Kids Summer Food Program helped my family tremendously last summer. If I did not have ACO's help with our groceries during the summer when the kids were home," said Erika, "I would have had to stretch what little food we had to feed them all."

In addition to the Kids Summer Food Program, ACO offers programs and services for income support assistance with rent, utilities, clothing and medical visits. Their Education and Employment Programs go beyond immediate needs to offer guidance for long-term self-sufficiency.

These programs are made possible by local donations from friends and neighbors in the community. Please share the message and GIVE WHERE YOU LIVE this summer to support families in need.

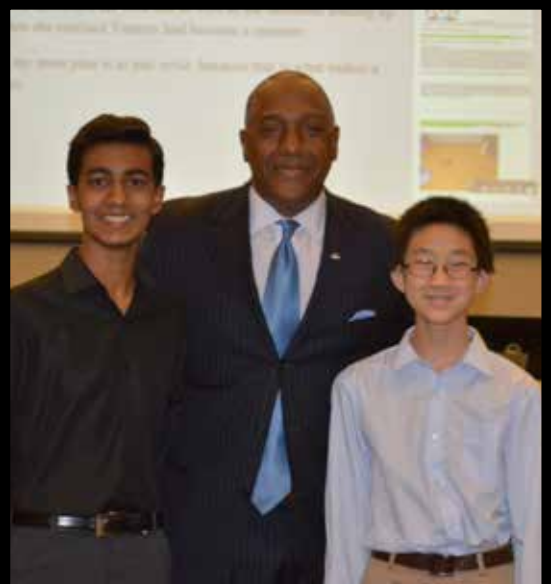
