SUBJECT: **Quarterly Investment Report – March 31, 2017**

BACKGROUND: It is the objective of the Town of Fairview to invest public funds in a manner which will provide maximum security and the best commensurate yield while meeting the daily cash flow demands of the Town and conforming to all federal, state and local statutes, rules, and regulations governing the investment of public funds. In January 2017, the Town adopted an updated investment policy which serves to satisfy the statutory requirements of defining and adopting a formal investment policy. The investment policy states, "Not less than quarterly, the Chief Financial Officer shall submit to the Town Manager, Mayor and Town Council a written report of the Town's investment transactions within ninety (90) days of the preceding reporting period."

STATUS OF ISSUE: The current depository bank for the Town of Fairview is Wells Fargo Bank. The current agreement with Wells Fargo specifies the Town to maintain an amount of liquid funds in Wells Fargo to allow the Town to earn interest monthly, which one-day interest rate at March 31, 2017 was 0.23%. The Town invested the majority of the remaining funds in the public investment pool – TexPool and Lone Star, which one-day interest rate at March 31, 2017 was 0.62% and 0.92%, respectively. All funds on deposit with Wells Fargo Bank, TexPool, and Lone Star are fully secured and safeguarded. Total interest earned for the quarter ending March 31, 2017 was \$19,283. The total cash and investments for the period ending December 31, 2016 was \$20,117,422 compared to \$20,960,228 on March 31, 2017, a net increase of \$842,806.

The Town's current portfolio has same day access, which is sufficient to cover normal and seasonal operation costs. It is the strategy of the Finance Department to maintain a high percentage of its idle funds invested in safe and secure investment securities and pooled investment types in accordance with the Public Funds Investment Act. As the economy slowly gains strength again, the Investment Officers will begin to explore other investment opportunities.


