# FAIRVIEW PLANNING AND ZONING COMMISSION MEETING MINUTES APRIL 11, 2024

Application: Casey McBroom, Cross Engineering representing owner Jonathan and Gail Bentley.

The 19-77-acre site is located at the southwest corner of Stacy Road and Orr Road (FM 317) and is zoned for the (RE-2) Two-acre Ranch Estate District. Applicant: Michael Westfall, Westfall Engineering representing owners Brian and Janna Jarvis.

c. Consider, discuss and take necessary action on a request for approval of a Replat of Lot 3 of the Country Club Estates Addition into two (2) lots. The 4.263-acre site is located at 1180 Red Oak Trail and is zoned for the (RE-2) Two-acre Ranch Estate District. Owner/Applicant: Chanc Woods.
