# FAIRVIEW TOWN COUNCIL MEETING MINUTES JULY 2, 2024

The Town Council met in regular session on July 2, 2024 at 7:30 PM at 372 Town Place, Fairview, Texas.

<u>Council present</u>: Mayor Henry Lessner and Mayor Pro Tem John Hubbard, and Council Members Rich Connelly, Gregg Custer, Ricardo Doi, Larry Little, and Ken Logsdon.

Mayor Pro Tem Hubbard called the meeting to order at 6:00 PM and declared a quorum was present.

Mayor Lessner and Council member Logsdon were not present when the meeting was called to order. Both Council members joined in executive session.
