No discussion or action may be taken at this meeting on items not listed on this agenda, other than to make statements of specific factual information in response to a citizen's inquiry or to recite existing policy in response to the inquiry.

- 8. Public Hearing (26:38)
 - a. Continue a public hearing and consider approval of an ordinance for a request for approval of a Major Warrant for revised build-to-zone requirements for a proposed townhome project along Fairview Parkway. The 15.2-acre sites are generally located on both sides of Fairview Parkway, north of the Fairview Village Road/Latham Drive intersection and is zoned for the (CPDD) Commercial Planned Development District with the Urban Village Sub-district. Applicant: Justin Cooley, Range Water Development LLC representing Travis Parker Associates, LTD Approved
 - b. Hold a public hearing, consider approval of an update to the Town of Fairview Master Parks Plan. (A majority of the Parks and Recreation Advisory Board may be in attendance, however, no formal action will be taken by the Board) Approved
 - c. Hold a public hearing and consider approval of an ordinance for a request to amend the zoning to reflect a revised development plan for a portion of the Collinwood Acres Addition. The 9.6-acre site is located on the west side of County Club Drive, north of Old Stacy Road and is zoned for the (PC) Planned Center District. Hold a public hearing and consider approval of an ordinance for a request for approval of Major Warrants on a regulating plan for the development of a multi-family project within the Lincoln Town Center on two sites. Tract 1 is a 5.6-acre site located on the east side of Fairview Station Parkway, between Town Place and Murray Farm Road. Tract 2 is a 3.9-acre site, located at the southwest corner of Murray Farm Road and Indian Spring Road (formerly the community garden area). Both sites are in the (CPDD) Commercial Planned Development District with the Urban Village sub-district. Applicant: Tommy Mann, Winstead PC representing Village FV LTD Approved

Stacy Road, west of Orr Road, and is zoned for the (RE-2) Two-acre Ranch Estate District. Owner/applicant: Mamoon Kundi. Approved
 - b. Discuss possible amendments the town charter and take any necessary action. Discussion Only
 - c. Discuss COVID-19 activities and actions and take any necessary action. Discussion Only
 - d. Discuss Boards, Commissions and Committees and take any necessary action. Appointments made

Section 551.071 – to consult with legal counsel regarding pending or contemplated litigation and/or on matters in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code including CPDD development improvements, ordinances, agreements and financing; contracts for services; town property and infrastructure; drainage matters; town ordinances, global opioid statement.

Section 551.072 - discuss or deliberate the purchase, exchange, sale, lease, or value of real property; acquisition of right-of-way, easements, or land.

Section 551.074 Personnel - appointment of members of all non-advisory boards and commissions.

The council further reserves the right to enter into executive session at any time throughout any duly noticed meeting under any applicable exception to the Open Meetings Act.
