  - a. Approve the minutes of the November 6, 2018 regular Council meeting.

# 5. Public Hearings

- a. Conduct a public hearing, consider and make a recommendation on a request for approval of Major Warrants to accommodate the development of a 3,500+/- square foot retail building. The site is located at 119 Stacy Road, at the northwest corner of Stacy Road and Whistlestop Way and is zoned for the Commercial Planned Development District (CPDD) with the Urban Village Sub-district. Applicant: Tim Smith, Lincoln Property Management, representing Sleep Number. (MW2018-4). Approved
- b. Conduct a public hearing, consider and make a recommendation on a request for approval of a conditional use permit (CUP) for a one-story; 2,400 square feet accessory structure, that will replace two (2) existing structures. The site is located at 641 Meandering Way and is zoned for the (RE-1) One-Acre Ranch Estate District. Owner/Applicant: Rick Zampino. (CUP2018-7). Approved

- a. Consider and take necessary action on a request for approval of a Final Plat for the Heritage Oaks Addition. The 16.3-acre, 13-lot, single-family subdivision is located on the north side of Hart Road, approximately 670 feet west of the intersection of Hart Road and Country Club Road and is zoned for the (RE-1) One-Acre Ranch Estate District. Applicant: Stephen DiNapoli. (FP2018-03). Approved
- b. Hear presentation on annual solid waste activities, discuss status of recycling and consideration of an ordinance approving a rate increase related to recycling and take any necessary action. Approved
- c. Consider, discuss and take any necessary action on an ordinance amending water and sewer rates. Approved
- d. Consider, discuss and take any necessary action on an Interlocal Agreement with the Town, NTMWD and City of Allen; and an ILA between the Town and the City of Allen regarding funding and construction of a regional sewer pump station. Approved
- e. Discuss planning for future town fire facilities and operations including planning studies, upcoming meetings and any related matters, and take any necessary action. Discussion Only
- f. Discuss Boards & Commissions and take any necessary action. Deferred to January meeting

Section 551.071 – to consult with legal counsel regarding pending or contemplated litigation and/or on matters in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code including CPDD development improvements, ordinances, agreements and financing; code enforcement issues; Robert Bruce Kelly and Shannon Shirey Kelly vs. Town of Fairview, Case No. 380-04945-2018 in the 380<sup>th</sup> Judicial District, Collin County, Texas; Mark Edward Stoddard and Bertel Morgan Stoddard vs. Town of Fairview, Case No. 296-04944-2018 in the 296<sup>th</sup> Judicial District, Collin County, Texas.

**Section 551.072** - discuss or deliberate the purchase, exchange, sale, lease, or value of real property; acquisition of right-of-way, easements, or land.

**Section 551.074 Personnel** - appointment of members of all non-advisory boards and commissions.

Section 551.087 – to discuss or deliberate Economic Development Negotiations: (1) To discuss or deliberate regarding commercial or financial information that the Town of Fairview has received from a business prospect that the Town seeks to have locate, stay, or expand in or near the territory of the Town of Fairview and with which the Town is conducting economic development negotiations; or (2) To deliberate the offer of a financial or other incentive to a business prospect described by subdivision (1). Proposed commercial/retail developments.

The council further reserves the right to enter into executive session at any time throughout any duly noticed meeting under any applicable exception to the Open Meetings Act.
