  - a. Consider and take necessary action on a request for approval of a preliminary plat for the Woodland Farm Estates Addition. The 20.7-acre tract of land is located north of Old Stacy Road, between Collinwood Drive and Lakewood Drive and is zoned for the (RE-2) Two-acre Ranch Estate District. Applicant: Doug Mousel, LandPlan Development. (PP2016-02). Denied Without Prejudice by the Planning and Zoning Commission.

  - a. Conduct a public hearing, consider and take necessary action on a request for approval of a Conditional Use Permit (CUP) for a sport court.   - b. Conduct a public hearing, consider and take action on a request for approval of a Major Warrant for a Master Sign Plan for the Village at Fairview. The site is located at the northeast corner of Central Expressway and Stacy Road and is zoned for the (CPDD) Commercial Planned Development District. (Case #MW2016-01).

Proposed commercial/retail developments.
