Mayor's Note

I would like to invite each of you to join the Town Council and your neighbors on Saturday, March 28th for the town's Annual Volunteer Clean-up Day. This is an opportunity for us to work together to improve our community, our home, while getting to know your fellow neighbors. We want this to be day of community pride and service, so bring the whole family! We will meet in the Town Hall parking lot at 7:30 a.m. to receive our assignments for the day. For more information, contact James Chancellor at jchancellor@fairviewtexas.org. I look forward to your participation.

Following discussions at the January and February Town Council meetings, the Town Council has agreed upon, and I am pleased to share with you, our top five town initiatives for 2015. In addition to keeping us focused and goal oriented, these initiatives also enable us to remain accountable to you for continuous improvement. The top five initiatives are:

Improve Town Communication Tools – We are exploring opportunities to promote increased transparency in order to better communicate with our residents. As the year unfolds, we will be placing additional financial data on our town website. We will also be making enhancements to our website and improvements to our town newsletter.

Complete the 5-Year Capital Improvement Plan – Our Capital Improvement Plan (CIP) identifies projects the town needs to undertake in order to secure infrastructure that will support our current and future needs, including water, sewer, drainage and facilities.

Continue to Focus on the Commercial Planned Development District (CPDD) – In 2014, we updated our CPDD code. We plan to continue to build on our momentum with the

CPDD by working with the Fairview Economic Development Corporation (EDC) to finalize our revised Economic Development Plan. We will finalize the financing tools that will be used to build out the infrastructure of the Northeast Section. We will continue to work with the Village at Fairview to review and consider proposed improvements. We will utilize the \$855,000 of county funding received in 2014 to complete the engineering and design of Fairview Parkway.

Explore Alternative Sources of Water – We will review, assess and determine the viability of pursuing alternative sources of water.

Update Park and Trail Plan – We will be working with our town Parks and Recreation Advisory Board to update our Park and Trail Plan. For our 2014 Fairview Citizen Survey, we heard our residents call for improved parks and trails throughout our community.

COUNCIL'S CORNER

At the February Town Council meeting, the Town Council addressed the following items:

- Approved minutes from previous meetings.
- Approved an ordinance calling the May 9, 2015 General Election and authorized the town manager to execute a joint agreement with Collin County for the provision of election services.
- Approved an ordinance amending the fee schedule of the town in order to establish emergency medical services billing and collection fees.
- Approved a request by Mr. David Keith for a Conditional Use Permit (CUP) in order to allow for the construction of an accessory building on a property that is zoned One-Acre Ranch Estate (RE-1) and is specifically located at 638 Merlot Court, being Lot 16 of the Vineyards at Fairview Addition to the Town of Fairview.
- Approved a request by Mr. Sam Price to approve an ordinance rezoning a 17.529± acre segment of Lot 1, Block A of the Ward Addition to the Town of Fairview, from the Agricultural (AG) zoning district to the One-Acre Ranch Estate (RE-1) zoning district.
- Approved a resolution of support for a request from Anthem Builders regarding a proposed veteran focused townhome project, Warrington Station, to be funded through the federal tax credit program.
- Discussed the town's priorities for 2015.
- Received a monthly financial report for the period ending December 31, 2014 and a quarterly investment report for the period ending December 31, 2014.

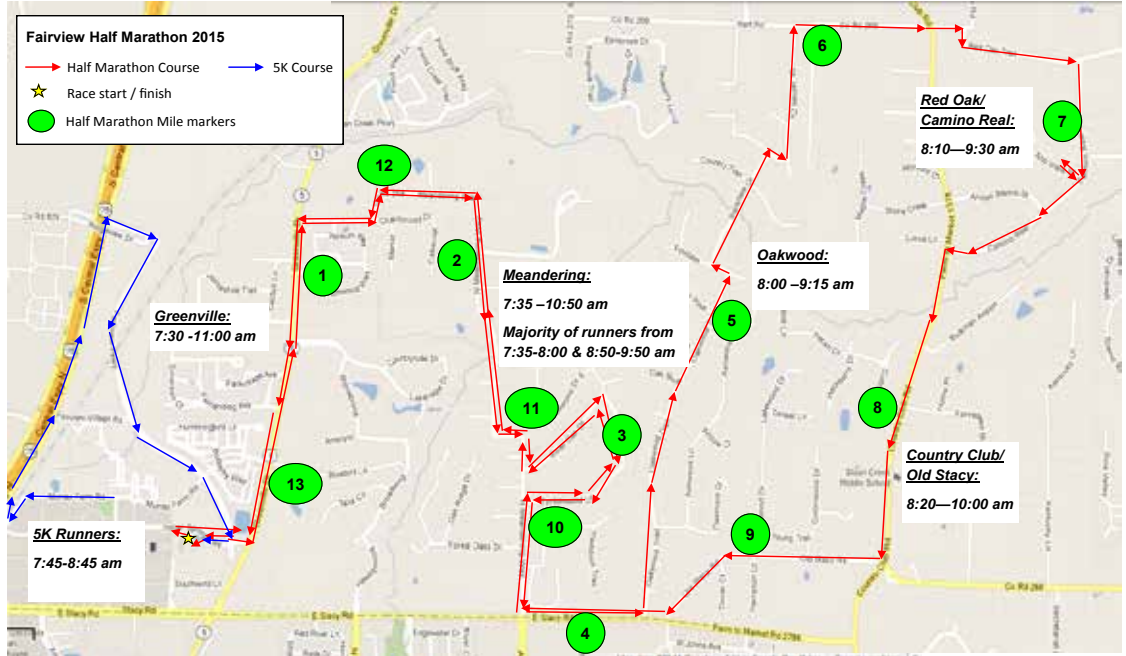

Gus Macker 3-on-3 Charity Basketball Tournament

Fairview Fire Rescue 2015 Awards Banquet

On Saturday, January 17, an awards banquet was held at the Heritage Ranch Club House to recognize the efforts of the firefighters and officers of Fairview Fire Rescue (FFR). This was the first awards banquet for FFR, and we hope it will continue on an annual basis. Joining the firefighters were: Mayor Culbertson and all 6 Town Council Members, as well as members of Friends of Fairview Firefighters and invited guests.

Throughout the evening, there were several awards given. Among them:

Service Awards - Recognizing the years of service with Fairview given by all members which combined equals 176 years!

Lifesaving Award - Given to two FFR crews and the crew of AMR's medic unit for a successful CPR save of a bicyclist down on the side of Stacy Road on August 15, 2013.

Engine 751 - Captain/EMT Jeff Kendrick; Engineer/Paramedic Justin Miller; Firefighter/EMT Tanner Spurgin

Truck 752 - Captain/Paramedic Danny Anthony; Driver/Firefighter/Paramedic Taylor Kyles; Firefighter/Paramedic Kari Reed

AMR Medic 752 - Paramedic Dustin Allen; EMT Kyle Roland (also Fairview Firefighters)

Officer of the Year - Captain Marcus Allen was

presented this award having demonstrated outstanding work habits, excellent performance of his duties, and strong leadership. He was also recognized for knowing all aspects of his emergency response responsibilities and showing a willingness to learn more and to go to numerous courses for advanced skill development. More than anything else, he was singled out for sharing his skills, experience and knowledge with his crew and all department members.

Firefighter of the Year - Firefighter/Paramedic Taylor Kyles was this year's winner. Here is what some of his peers had to say in their nomination of Taylor:

"...always willing to help when needed"

"He portrays the type of solid characteristics we need in this growing department."

"He will have your back on or off duty."

"Always a positive attitude anytime he is at work."

Planning and Zoning Commission

The Planning and Zoning Commission is comprised of seven commissioners. The current commission includes Chairman Brad Northcutt, Vice Chairman Pat Friend and Commissioners Ricardo Doi, Heather Hager, Debbie Flood, Mike VanNatta and Leslie Knight.

It is the Planning and Zoning Commission's duty to make and recommend a master plan, as a whole or in parts, for the future development and redevelopment of the town. The commission hears, recommends and determines matters related to zoning, platting and subdivision control as specified or required by town ordinance, charter and state law.

Economic Development Corporation (EDC) and Community Development Corporation (CDC) Board of Directors

The EDC and CDC Board of Directors are comprised of seven board members, with each member serving on both the EDC and CDC board. The current boards include President Warren Westberg, Vice President Sim Israeloff and Board Members Pam Little, Robert Herrema, Don Braun, Mary Price and Bill Nicol.

The EDC Board of Directors is responsible for promoting the economic growth and diversification of the Town of Fairview, and for overseeing the half-penny sales tax collected for this purpose. The CDC Board of Directors is responsible for promoting the community through infrastructure construction projects funded through the half-penny sales tax collected for this purpose.

Board of Adjustment

The Board of Adjustment (BOA) is comprised of nine board members. The current board includes Ricardo Doi, Gregg Custer, Ed Hayes, David Logan, Terry Morrow, Gene Harrington, Joe Barton King, Glenn Messner and Donna Cunningham.

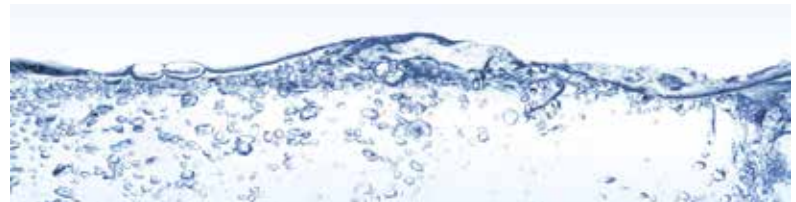

Fairview EMS Transport Service

The Town of Fairview will be moving away from our third party emergency EMS transport provider, AMR, to our own in-house service effective April 1, 2015 at 7 a.m. We have been studying moving this service in-house for a long time and believe now is the appropriate time. We are making this change in order to have better control over our costs and to have a closer oversight on the quality of care we provide. This move will also enhance our fire response capabilities. **NOTE: There will be no change to how you receive this service. Just dial 911 as you do today!**

Fifteen years ago, the Fairview Town Council decided to enter into an exclusive contract with a third party ambulance provider, so we could provide a much quicker response for our citizens and customers. Over the years, we have used several different companies to provide this service, including AMR, which has been our provider the last 8 years. All third party companies provided: 1 ambulance, 1 Paramedic, and 1 EMT, 7 days a week, 24 hours per day based at one of our fire stations. They were also responsible for all maintenance of the vehicle and equipment and handled all of the billing.

In order to get ready for this service, we needed to enhance our dispatch

services. The Town Council agreed to enter into a contract with the City of Wylie Public Safety Communications in January 2014. This move allowed for a much faster response to all calls (EMS and Fire) and added a much needed Emergency Medical Dispatch (EMD) function in the communications center. After 12 months with Wylie, we have, on average, been able to cut at least 1 full minute from our response times, while significantly improving the information our personnel receive from the dispatchers while in route to the emergency scene.

We also needed to lay out a plan for adding personnel and equipment. For staffing, we will be adding 6 new full-time personnel (2 per shift). This will mean we will have at a minimum 1 paramedic and 1 EMT on the ambulance (just like with the current program), but at many times we will have 2 paramedics on board. The important difference in our new program is that ALL personnel on the ambulance will be members of Fairview Fire Rescue and all will be firefighters. This means that we can now use these ambulance crew members to assist in all activities in the fire department, not just for EMS calls. The cost for these new firefighter/paramedics will be offset from the amount we were paying to AMR.



As for equipment, we have purchased one new primary ambulance that will be delivered in mid-April. We also purchased and received delivery of one previously owned ambulance which will serve as a replacement unit in order to allow us to immediately place it in service if the primary ambulance is out for maintenance work. In the current third party system, a replacement ambulance typically has to come from Addison which results in a lengthy delay. This replacement unit will serve as the primary ambulance starting April 1 until the new one is delivered. The new primary ambulance will be housed at Fire Station #2 on Stacy Road, just as we are doing with AMR today. We can also staff the replacement ambulance, but only for events like the town's half marathons or in preparation for a major storm, if needed. All equipment on the ambulances will be state-of-the art, which will enhance our ability to share information with hospitals and to minimize paperwork. This will result in a better patient care experience.

If our primary ambulance were to be out on another call or at the hospital when a second emergency call comes in, we will call for a backup ambulance provided by mutual aid fire departments (Allen, McKinney, or Lucas) just like we are doing today. While that mutual aid ambulance is responding, a Fairview fire truck with a paramedic and advanced life support equipment will be responding, as well, in order to get to you as quickly as possible.

As for the cost of a transport, our objective was to keep the costs our customers saw on their bills in line and in many cases less than what AMR is charging. All billing for this new service will be handled by a Dallas-based professional ambulance billing company, Emergicon, who will meet regularly with us to ensure their services are meeting our expectations. Unlike the current contract with AMR where they received all revenues, the town will now receive all revenues per transport less processing fees for Emergicon.

Bottom line, the end user experience for this new, in-house service should be better than what we have been providing for the past 15 years, while controlling costs. We are very excited to begin this service and to better meet our customers' emergency medical needs. We will have additional information about this change on our web page for your review when the service starts on April 1.

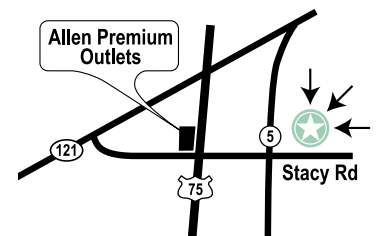

LOVEJOY SCHOOL

To learn the history of the Lovejoy School, one has to first learn of the Lick Springs School. This school was established in 1871 and was located five miles southeast of McKinney on top of the hill just after crossing the bridge on Sloan Creek on the old McKinney to Rockwall Road (now Country Club/FM 1378). It was about 50 yards east of the road to Forest Grove. It was called Lick Springs because deer, buffalo and other wild animals came there and licked large holes in the banks of Sloan Creek. The holes were as deep as the deer could reach, possibly three to four feet, and perfectly smooth on the inside. The building was a log house about fourteen feet square with no windows. There were two terms in the summer, and there was no school in the winter since there was no way to make a fire.

In July 1884, Forest Grove School began. It was about two miles from Lick Springs. In 1887, James M. Snider, "in consideration of the love I have for education", gave, from land he had bought from Aunt Francis Fitzhugh, a plot north of the Forest Grove Christian Church lot, for Forest Grove School established earlier.

Claude Cecil Martin was a teacher at both Forest Grove and Lick Springs. He was from the hills in East Tennessee. Mr. Martin began a petition to consolidate the two schools. The communities served by the schools had historically been two distinct communities and the consolidation was unpopular with some people. However, CC. Martin went from house to house obtaining signatures for his petition. His brother, J.G. Martin, representing the Forest Grove School District, and C.B. Watson, representing Lick Springs School District, presented the petition to the County School Board. On July 2, 1917, the Lovejoy Common School District, Number 32 was established, combining the two old schools. A new building was built with four classrooms. It was painted white and had large many-paned windows. There was, of course, no cafeteria or indoor restroom, but it was a model educational facility in 1918. The students, mostly farm children, came to school on foot or horseback.

It was decided that the school would be named in honor of Carrie Louise Lovejoy, a lady whom, for many years, had been involved in the education of the children in the area.

Who was Carrie Louise Lovejoy?

She was born Carrie Louise Emerson on March 31, 1861 in Wisconsin. Her father Frances Emerson was born in Lurgan County of Armagh,

Carrie Lovejoy was widely loved and respected in Collin County. She was untiring in her efforts on behalf of women and children, especially in rural areas of Collin County.

Ireland. He came to America when he was thirteen and learned the coppersmith trade. He repaired and fitted out steamships in New Orleans. Upon returning to Ireland, he met and married a Scottish girl, Elizabeth Thompson, in 1836. As newlyweds, they sailed for America and settled in Monroe, Green County, Wisconsin where Emerson established a hardware business and a factory to make wagons and buggies. In 1854, he made the first of several trips to Texas before he brought his family to settle in Dallas. It was there that he, again, started a hardware business. After the War Between the States, he and his family moved to McKinney and entered the general merchandising business. He started the first bank in McKinney, a private firm, that was eventually the First National Bank.

Daughter Carrie Louise married John L. Lovejoy in 1879 in McKinney. Her husband was a stockholder and official of many firms and corporations, president of the First National Bank and owner of over 1,000 acres of land in Collin County.

Carrie Lovejoy was widely loved and respected in Collin County. She was untiring in her efforts on behalf of women and children, especially in rural areas of Collin County. Her "enthusiasm, with her inevitable smile" won respect and cooperation.

Texas Women's Hall of Fame Yearbook, 1915 lists an impressive number of clubs in which she served. Her activities carried her to every corner of the county. She organized mother's clubs at rural schools before there was PTA. She worked to get school cafeterias. She took crates of books to schools without libraries and, on the next visit, brought more books, picked up the last batch and carried them to another school. As a member of the Owl Club in McKinney, she helped set up nine traveling libraries. Each library had 50 books for three months. She escorted the first Home Demonstration lady to rural communities and helped organize Home Demonstrations, canning and girls' clubs. She was determined that the rural schools should have the same excellence as

the city schools.

Mrs. Lovejoy scattered wildflower seeds from trains as she traveled and promoted planting blooming trees. Not only did she work to make the country more beautiful, she is remembered as a woman that was beautiful inside. The old newspapers of 1914 and 1915 are filled with her efforts to get everyone to plant pretty trees. She worked with any group she could find interested in the project.

When the Stock Market crashed in October 1929, she, again, stepped in to help. She knew farm girls would have no way to get to the high school and would never get to attend school past the little rural schools level. She opened her lovely, elegant home to girls wishing to go to the high school, furnishing them a room and board. The fathers wanted to help (not with money, for no one had any), so they brought farm produce to the home. Perhaps a bushel of fruit from the farm, a cured ham, or bacon, a bushel of sweet potatoes, or whatever the farm produced. Dozens of girls took advantage of this lovely home and graduated from high school.

Evelyn Shipman recalled several years ago that when she was about eight years old, Mrs. Lovejoy saw her admiring crepe paper roses the Home Demonstration Club at Lovejoy had made. She volunteered to come to her home to show her how to make roses and dip them in wax. "I just loved that old lady."

Carrie Louise Lovejoy died on September 13, 1939 and is buried next to her husband, John, who died in 1921, at the Pecan Grove Cemetery in McKinney. When she died, she left Lovejoy School one thousand dollars; part of which was used to lay the first concrete sidewalk at the school and to purchase a piano and a record player.
