WATER SAVING TIPS

ATTENTION:

The month of May brings warmer temperatures, and for some, this might mean using more water on the lawn and garden to keep up with the heat. It's important to remember that although our community prides itself on its natural beauty, we must be conscious of our water usage—especially amid the current Stage 2 drought conditions. Below are some regulations established by the town related to water use:

- Do not water your lawn between the hours of 10:00 am. and 6:00 p.m. from April 1st through October 31st.
- Do not allow water to overspray on impervious surfaces such as paved roads and sidewalks.
- Do not water your lawn during rain or freeze events.
- Lawn and landscape irrigation is limited to twice per week.
- Home car washing can be done only when using a water hose with a shut-off nozzle.

But that's not all. There are many other opportunities to help conserve water. Below are a variety of other tips that you might find helpful.

- Repair leaks, running toilets, dripping faucets, and broken sprinkler heads.
- Water in the morning or evening when the temperatures are cooler.
- Plant native, drought tolerant plants that require less water.
- Adjust your lawn mower at least one notch. A taller lawn holds more moisture.
- Water only when plants look like they need it. Most plants die from over watering.

So, remember, whether you're enjoying time in the garden, working on keeping your lawn beautiful, or enjoying some other summer activity, there are many opportunities to help conserve water. If any changes occur related to the status of what drought stage the town is in, town staff will keep all residents apprised of what those changes mean and when they would become effective.

**NOAH'S OF FAIRVIEW
OPENING IN MAY**

Noah's of Fairview, a public/private partnership between the Town of Fairview, the Fairview Economic and Community Development Corporations and The Noah's Corporation is under construction with completion planned in May. The land and the building are owned by the town and the facility will be operated and managed by Noah's, who has a long term lease with the Town. The Community and Economic Development corporations of Fairview back the debt with sales taxes committed to economic and community development. Noah's of Fairview is a neighborhood event center that offers an alternative to traditional meeting venues. The 9,000 square foot building is constructed of high quality materials, including a solid walnut floor and state of the art electronics. Space is designed to be multi-functional to meet the needs of both corporate and family users. Noah's does not engage in food and beverage functions, so patrons are free to choose their own caterer or even bring in their own food and beverage.

Noah's will hold an open house on Saturday May 18 from 3 p.m. until 6 p.m. to give people the chance to see the facility up close. There will be food, beverage and entertainment. While the set up will be primarily focused on weddings, the public is encouraged to tour this great addition to our community. On May 23 at 5:30 p.m., Noah's will hold a ribbon cutting and a business gathering for the Allen-Fairview Chamber of Commerce and local businesses. The public is welcome to this event as well.

**SH5 ROAD PROJECT
UPDATE**

The Texas Department of Transportation (TXDOT) has an upcoming construction project on State Hwy 5 (Greenville Ave) to straighten out the sharp curves at the RR tracks just south of FM1378. This project will construct two 12' wide lanes with 10' wide shoulders and smooth out the curves. Drainage will be improved, and sight distance will be increased. The project is scheduled to begin May 1, if all of the utilities are moved. Some work can begin without closing the road and TXDOT has identified these items to town staff. The project will require a complete road closure for up to six months once it is officially closed. This closure could happen as early as mid-May even though Fairview has requested that they wait until after schools lets out for the summer. US75 and FM1378 will be the alternate routes during this construction. A temporary U-turn will be installed on the south side of the bridge at the entrance to the Sloan Creek subdivision for cars and trucks that inadvertently miss the warning signs. Our New Friend

In what is surely a product of Fairview having the lowest property tax rate in the immediate area, a hawk recently set up its nest in our town! The Importance of Hawk Conservation

Hawks belong to a group of birds called raptors, which is a general term for birds of prey. Raptors include hawks, eagles, falcons, owls, osprey, and kites. Their main features include hooked beaks and long, sharp talons.

Due to their predatory nature, hawks and other raptors face distinct challenges in terms of species conservation. Changes to their food supply (including a decreasing amount of options, poisoned prey that can cause secondary poisoning to the raptors, and un-retrieved game birds that have been hunted with lead bullets) negatively impact raptors' ability to thrive in nature.

As such, hawks and other raptors must be treated with the utmost respect and care if they are to continue to take advantage of Fairview's natural beauty. Notice is hereby given that the Fairview Planning and Zoning Commission will meet on Thursday, May 9, 2013 beginning at 7:00 p.m. at Town Hall, located at 372 Town Place in Fairview.

- Conduct a public hearing, consider, and take any necessary action on an ordinance amending Chapter 14 (Zoning), Article 14.02, in order to amend the principle permitted uses of the One-Acre (RE-1), and the specific zone requirements for the One-Acre (RE-1), One-and-One-Half -Acre (RE-1.5), Two-Acre (RE-2), and Three-Acre (RE-3) Ranch Estate Zones. **(ZA2013-11)**
- Conduct a public hearing, consider, and take any necessary action on a request for approval of Conditional Use Permit (CU) Zoning in order to allow for an accessory structure on a property that is zoned One-Acre Ranch Estate (RE-1) and is specifically located at 111 Summer Hill Lane, being Block 3, Lot 21 of the Summer Hill Farms subdivision. **(ZA2013-13)**
