With school buses starting their routes, new high school drivers taking to our roads and the construction of the new Stacy Road, I ask that you stay alert, mindful and careful on the road.

Fiscal Year 2016-2017 Budget Process

With our new fiscal year starting on October 1, the Town Council and Staff have been busy working through the details of the Fiscal Year 2016-2017 budget. We held the initial Budget Workshop on August 1 with two public hearings on August 16 and August 24. The presentation on the proposed budget can currently be found on the Town website home page under Top News. Once adopted, Staff will also post the adopted budget on the Administration department page.

Fiscal Year 2016-17 Budget Highlights

- There are no property tax increases for the upcoming year, as the proposed property tax rate remains \$0.359999 per \$100 valuation, which is the same as last year's rate.
- We continue to have a strong General Fund Reserve, equal to 51 percent of the Town's General Fund expenses.
- The Town has an AA+ Debt Rating.
- We continue to receive water rate increases from the North Texas Municipal Water District and thus the Town's water rates also will need to increase.

A great big **THANK YOU** to all of the residents that packed Council Chambers to participate in our "Back the Blue" celebration! Your participation sent an absolute message to our Public Safety Officers that they are loved and appreciated!

COUNCIL'S CORNER

At the Monday, August 1, 2016, special Town Council meeting, the Town Council addressed the following items:

- Discussed the proposed 2016-2017 fiscal year budget including budget priorities, long-range planning, the budget process, the calendar, special meetings schedule and related items.

At the Tuesday, August 2, 2016, regular Town Council meeting, the Town Council addressed the following items:

- Received an Invocation by Minister Vince Smith, Executive Director of the Collin Baptist Association.
- Mayor Darion Culbertson presented a proclamation declaring August 2, 2016 as Law Enforcement Recognition Day in the Town of Fairview.
- Heard a report from Event Committee chair, Chris Hendricks, regarding the upcoming Gus Macker 3-on-3 basketball tournament.
- Approved the minutes of the June 27, 2016 special Town Council meeting.
- Approved the minutes of the July 5, 2016 regular Town Council meeting.
- Approved a resolution authorizing the Chief of Police to apply for grant for a body worn camera from the office of the Governor and accept if awarded.
- Approved, subject to legal form, an Interlocal Agreement with Collin County regarding jail services.
- Authorized the Town Manager to award a bid for reconstruction of Sharon Road in an amount not to exceed \$200,000.
- Approved an Amending Plat for Lot 17R-1 of the Montecito Estates Addition Phase 2. The 1.3-acre site is located on the north side of Meandro Ria Lane, east of Camino Real and is zoned for the (RE-1) One-acre Ranch Estate District. Applicant: Xan Thompson. (AP2016-01).
- Conducted a public hearing and approved a request for approval of a revised landscape plan for the Courts at Sloan Creek. The 6.5-acre site is located on the west side of Highway 5, south of Meandering Way and is zoned for the CPDD (Commercial Planned Development District). Owner: Kittyhawk LLC. Applicant: Jeb Nelson, Green Brick Partners. (SP2016-01).
- Conducted a public hearing and approved a request for approval of a Preliminary Plat for Harper Landing, Phase 2. The 46.2-acre site is located on the east side of Country Club Drive, between Farmstead

St. and Camino Real and is zoned for the (RE-2) Two-acre Ranch Estate District. Applicant: Bryon Reid, M. Christopher Custom Homes. (PP2016-01).

- Approved a request for approval of a Final Plat and Landscape Plan for Harper Landing Addition. The 72.95-acre site is located on the east side of Country Club Drive, between Farmstead St. and Camino Real and is zoned for the (RE-2) Two-acre Ranch Estate District. Applicant: Bryon Reid, M. Christopher Custom Homes. (FP2016-04).
- Approved an ordinance authorizing the issuance and sale of Town of Fairview Combination Tax and Limited Surplus Revenue Certificates of Obligation, Series 2016; levying an annual ad valorem tax and providing for the security for and payment of said certificates; approving an official statement; authorizing the execution of purchase agreement; providing an effective date; and enacting other provisions relating to the subject.
- Approved an ordinance authorizing the issuance of Town of Fairview General Obligation Refunding Bonds, Series 2016; levying an annual ad valorem tax and providing for the security for and payment of said bonds; approving an official statement; authorizing the execution of purchase agreement and escrow agreement; providing an effective date; and enacting other provisions relating to the subject.
- Approved the proposed tax rate for FY 2016-2017 and placement of a proposal to adopt the proposed tax rate on the agenda of a future meeting.
- Approved a resolution scheduling public hearings on the Town of Fairview proposed tax rate.
- Discussed the upcoming special council meetings regarding the budget, the tax rate and other work session items.
- Approved a professional services agreement with Huitt-Zollars for East Stacy Road reconstruction from Stone Hinge to Orr Road.
- Approved a contract extension for garbage services from Republic Services.
- Discussed the status of mosquito program.
- Discussed Boards and Commissions and made appointments to the Parks and Recreation Advisory Board and the Special Events Committee.
- Received the Monthly Financial Report for the period ending June 30, 2016.
- Received the Quarterly Investment Report for the period ending June 30, 2016
- Received an update on the Stacy Road construction project.

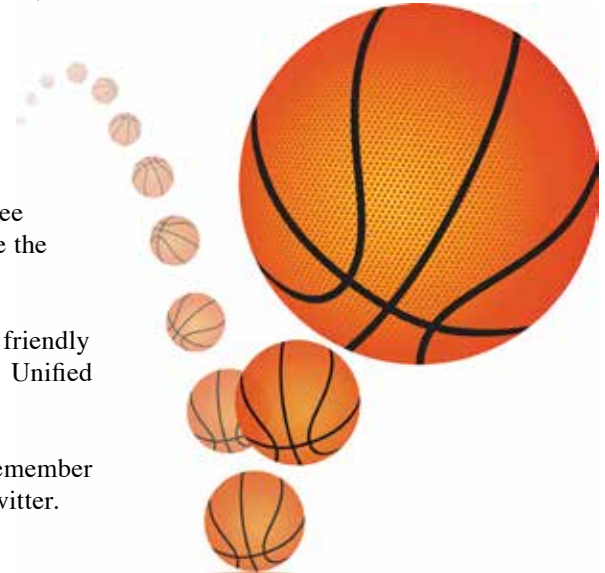
New at this year's tournament will be food trucks! Mad Grill, described as lean, mean Pan-Asian cuisine will surely be a hit with the crowd. And, for those who prefer a more traditional meal there is Very Individual Pizza with everything from pepperoni pizza to mac and cheese pizza, and to top it off they even serve Snow Cones. Both trucks will be onsite Saturday and Sunday beginning at 10:00 a.m.

The Macker Tournament is designed so that anyone can play: male or female, young or old, short or tall and the most experienced to none at all. This maintains the purity and integrity of the driveway game. Since 1987, the Macker tour has expanded, holding a total of 972 tournaments with over 2.2 million players of both genders from 7 years old to 50 plus and more than 23 million spectators. All teams are placed into male and female divisions according to pre-established age categories.

The Macker is a double elimination tournament where all teams will play at least three scheduled games. All games will be officiated by registered officials in order to enhance the competition, calling all fouls and violations, even in the Junior Divisions.

The tournament benefits Special Olympics of Texas and it promises a fun, family friendly atmosphere. In fact, there will be one court dedicated to Special Olympics of Texas Unified Teams.

Race Injury Prevention

As we ramp up our training for The 2016 Showdown Half Marathon and 5K, to be held on the morning of Saturday, October 8, 2016 as a part of Texas-OU Weekend, it is appropriate to address a topic that affects all runners, injury prevention.

Whether you are a new runner or an experienced marathoner, you will likely be impacted by general aches and pains or overuse at various points in your running career.

The following tips will help you become a more effective runner and will make the Showdown Half a more enjoyable experience:

Cross Train: The quickest way to become an injured runner is to run too much! While we

are training for the run, it does not mean that our training should only consist of running. By taking part in other activities such as cycling, swimming and weightlifting, you are giving your body the opportunity to recover from your running workouts, while also strengthening areas that are neglected in running.

Workout Frequency and Intensity: While you may be training for the half marathon, it will not require you to run 80 miles per week. A sensible workout schedule that calls for no more than three running workouts per week can be used to prepare a runner to excel in this event. Vary the intensity of the workout (sprints, tempo run, intervals, etc.) and the duration of the workout (mileage, time, etc.), based on how your body feels.

Treatment: Treat your body before the injuries develop! After your training runs, ice your legs and workout any remaining tension with a foam roller. Prior to beginning your training plan, ensure that your shoes fit properly and are appropriate for your running style/gait.

Online registration is now open for the Showdown Half Marathon and 5K. After the race, participants are encouraged to stay in Fairview and watch the Texas-OU game in a Fairview venue. National Pharmaceutical Take Back Day

Saturday, October 22
at Fire Station #1

On Saturday, October 22, from 10 a.m. to 2 p.m. at Fire Station #1, located at 500 S State Highway 5 in Fairview, the Town will participate in the Drug Enforcement Administration (DEA)'s collaborative effort with state and local law enforcement agencies to remove potentially dangerous controlled substances from our nation's medicine cabinets.

This national pharmaceutical take-back day will provide a unified opportunity for the public to surrender expired, unwanted or unused pharmaceutical controlled substances and other medications to law enforcement officers for destruction. This one-day effort will bring national focus to the issue of pharmaceutical controlled substance abuse. The program provides an opportunity for law enforcement to collaborate with the DEA and establish a safe collection site. This program is anonymous and all efforts will be made to protect the anonymity of individuals disposing of medications.

Controlled, non-controlled and over-the-counter medications may be collected from individuals. The general public is often unaware of the distinction in medication status. Participants may dispose of medication in its original container or by removing the medication from its container and disposing of it directly into the disposal box. Liquid products, such as cough syrup, should remain sealed in the original container. The depositor should ensure the cap is tightly sealed to prevent leakage. Intravenous solutions, injectables and syringes will not be accepted due to potential hazard posed by blood-borne pathogens.

Town Honors Police Department at Council Meeting

The Fairview Police Department was greeted with a packed house of thankful Fairview residents at the August Town Council meeting, where Mayor Darion Culbertson signed a proclamation making Tuesday, August 2, 2016, Law Enforcement Recognition Day in the Town of Fairview. In light of the recent tragedy in Dallas, the Town Council and Staff wanted to show their support for law enforcement both in Fairview and across the country.

The Council opened this meeting with a special Invocation by Minister Vince Smith, Executive Director of the Collin Baptist Association. The Council, staff, the Fairview Police Department and the large crowd in attendance for the Proclamation observed a moment of silence, in honor of all fallen officers and their families. Nationally, at the time of the proclamation issuance, there had been 59 line-of-duty deaths so far in 2016 and 130 in 2015, with an officer dying in the line of duty on average once every 61 hours.

The Council decided to take an extra moment to recognize the men and women of the Fairview Police Department after this tragic statistic hit even closer to home with the ambush attack on the Dallas Police Department and the Dallas Area Rapid Transit Police Department on July 7, 2016, which took the lives of five officers and caused injury to seven other officers and civilians.

“The Town Council of the Town of Fairview wishes to offer its sincere condolences and its support to the City of Dallas for the terrible loss of life and the impact this event has had on the City of Dallas, the Dallas Police Department and the families of those lost and injured. But beyond that we want to recognize and honor the hard work, dedication and risk taken by the men and women of the Fairview Police Department as well as by all law enforcement across the country,” said Mayor Culbertson.



STACY ROAD UPDATE

The underground storm sewer is near completion on the north side of Stacy Road. Grading and subgrade preparation, along with retaining wall construction is underway to prepare for paving operations this fall. Two concrete lanes on the north side will be constructed, probably beginning in October. Adjacent property and driveway owners will be contacted by the contractor, Ed Bell Construction, when ingress/egress is affected. No significant traffic switches are anticipated until the northern two lanes are available for traffic flow, which will be sometime this winter.

Taking full advantage of Fairview’s country feel and quaint beauty, The Showdown Half Marathon and 5K aims to provide a top quality running experience through Fairview, beginning and ending the race at our Town Hall.

The Fifth Annual Showdown Half Marathon and 5K will be held the morning of Saturday, October 8, 2016, on the same day as the Red River Showdown, the annual rivalry football game between the University of Texas Longhorns and the University of Oklahoma Sooners.

Local run organizer, The Active Joe, offers a top-quality run experience by offering the choice of a crimson or burnt orange shirt color, bib color, and medal color, as well as bib personalization with your name or a nickname of your choice. Pick a side in the rivalry- or don’t and join us for the run anyway!

The festivities begin at 7 a.m. with a kids’ dash. The half marathon will start at 7:30 a.m., and the 5K will start at 7:45 a.m.

The race will wind through Fairview and back to Town Hall. Please be aware that due to the Stacy Road construction, the course has been adjusted. Please review the above course map in order to help better plan for the day. While there will be no major street closures, there will be some traffic delays. Please plan for a little extra time if you are going out on that Saturday. The course will be clearing around noon.

TOWN QUARTERLY FINANCIAL REPORT FOR QUARTER ENDING JUNE 30, 2016

Monthly financial reports are prepared for the General Fund, Water and Wastewater Fund, Solid Waste Fund, Debt Service Fund, Stormwater Fund and Fairview EDC/CDC Funds, these reports are presented to the Town Council at their monthly meetings. These monthly financials can be accessed on fairviewtexas.org by selecting Departments/Administration/Audit-Budget.

This report covers through June 30, 2016, which is the end of the third quarter of fiscal year 2015-2016; therefore, it is generally desirable for year-to-date revenue totals to have achieved 75 percent of the budgeted amount and for expenditures generally not to have exceeded 75 percent of their budgeted amounts. However, because property taxes are primarily received during the first trimester of the budget year and other revenues such as franchise fees are cyclical, revenues will not always equate to the projected percentage. Likewise, total expenditures may not always equate to the projected percentage, because payments for contracted services, insurance and debt-service payments are paid in lump sum amounts, while transfers to other funds occur quarterly.

General Fund Analysis

Revenue collections in the General Fund for the ninth month of fiscal year 2016 total \$6,951,704 and represent 90.2 percent of the total annual budget. Actual total collection this year is \$809,937 higher than last year.



The top revenue category that is higher than last year is Property Taxes with a total of \$3,281,751, which is \$342,241 higher than last year due to the 8 percent increase in assessed valuations and several agriculture parcels being “rolled back” for collection of additional \$52,817 in delinquent taxes and penalties.

Charges for Services increased \$133,756 over the prior year primarily due to the Town

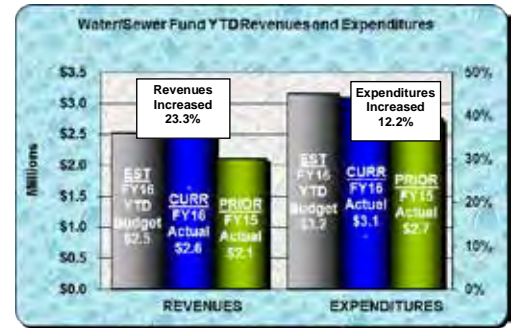
receiving \$73,549 in engineering fees related to development and the EMS transport fees received from the in-house ambulance services now provided by the Town that began in April 2015. Transfers from other funds were higher than last year by \$635,000, related to the funds set aside at the end of the previous fiscal year in the Capital Projects Fund. The Town has transferred these funds back to the General Fund for capital and one-time expenditures budgeted in the current fiscal year.

The top revenue category that is lower than last year is Miscellaneous, with a total of \$149,394, which is \$366,753 lower than last year due the Town receiving \$380,000 debt proceeds in the previous fiscal year to purchase EMS vehicles and equipment. Franchise fees are down by \$23,601 due to timing of payments being received in July instead of June.

General Fund expenditures total \$4,905,678 and represent 63.3 percent of the total annual budget. Expenditures are \$49,858 more than the previous year and expenditures for all divisions are within the acceptable range. The decrease of expenditures in the Planning and Fire Departments can be contributed to less contractual services being provided and not purchasing the in-house EMS capital as in the prior year, respectively. The increase of expenditures in Non-Departmental is due to the \$34,060 portion of the 380 Agreement payment to The Village at Fairview and the Town Hall fountain maintenance, which was not budgeted last year. The increase in Public Works was due to Capital equipment purchase of \$26,964 and an increase in maintenance cost of \$12,179. The Town transferred \$160,490 to the Technology Fund, which is \$64,101 higher than the previous fiscal year due to added budgeted technology expenditures this fiscal year.

Water & Wastewater Fund Analysis

The Water and Sewer Fund revenues total \$2,922,829 and represent 53.9 percent of the total annual budget. This amount is \$465,167 higher than last year. Water sales were higher by \$249,285 than the previous, while Miscellaneous revenue was higher by \$26,568 than the previous year due to a higher refund from the North Texas Municipal Water District (NTMWD) on over-payment for billed water. Due to timing of the transfer from the Debt Service Fund, an increase of \$189,274 occurs in the transfer category when compared to the



prior fiscal year.

Expenses for the Water and Sewer Fund total \$3,594,911 and represent 56.1 percent of the original annual budget. This amount is \$371,520 higher than last year. An increase of \$158,068 or 10.0 percent occurred due to the increase in water purchase rates and sewer treatment rates established by the NTMWD.

Other Funds Analysis

The increased expenditures in the Fairview EDC and CDC funds of \$291,682 and \$220,366 respectively are primarily due to the 380 Agreement with The Village at Fairview. The revenues and expenditures for all the other operating funds are within an acceptable percentage range. Revenues and expenditures will be monitored and reported to ensure that spending will not exceed the approved budget amounts.

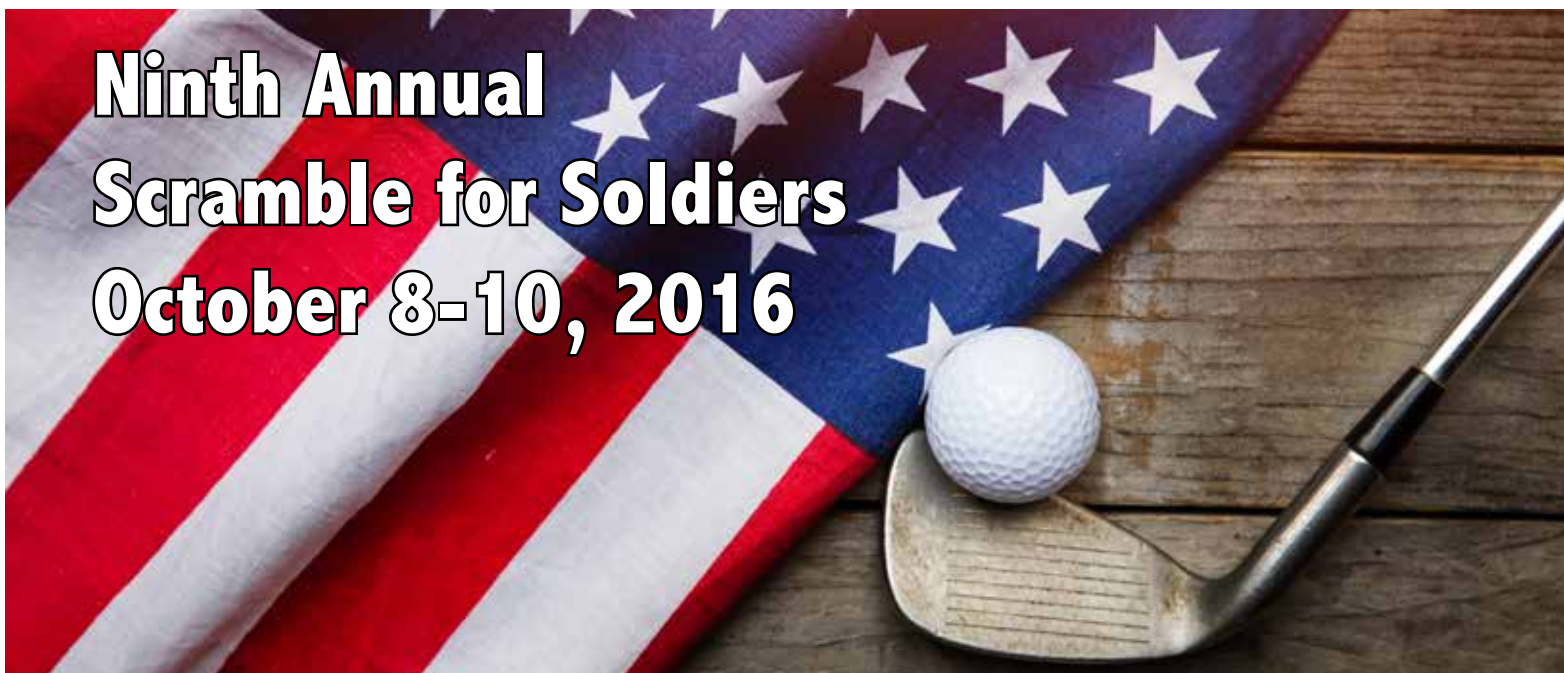
Sales Tax Analysis

Sales tax revenue collections for the entire Town of Fairview (Town, Fairview EDC and CDC portions) for ninth month of fiscal year 2016 total \$2,408,408. Actual total collection this year is \$137,883 or 6.1 percent higher than last year.

The Town of Fairview received \$223,347 in sales tax revenue during the month of June 2016. This amount represents an increase of \$15,361 or 7.4 percent more than during June 2015. Due to the timing, the sales tax received in the month of July 2016 can be reported in this financial report too. The Town of Fairview received \$228,277 during the month of July 2016. This amount represents an increase of \$7,532 or 3.4 percent more than during July 2015.
