



# MESSAGE MAYOR FROM THE

## Dear Veighbors,

Welcome to October! Where has this year gone?

I hope that those of you who are involved in school at any level and any role are surviving. I especially appreciate the teachers who have had their worlds turned upside down since March of this year.

I know that in Fairview, for some of you, access to the internet has been a real challenge. I have heard of residents driving into Allen to rent a hotel room to work. I have been told by my preacher's son that when he was delivering Bibles to third graders in Fairview this past month, he was sometimes met at the door by a crying child; crying because they were upset because they thought they would be in trouble at school because they can't get their lessons done because their internet was down.

So, what can we as a Town do about this? The honest answer is not much as the laws favor the providers and the Town has no leverage over the providers. This is something that must be changed at the state level and maybe at the federal level. So here is what we are doing:

- 1. Trying to work with the providers to get them to give the Town information about their outages and their plans for Fairview.
- 2. Escalating outages and other service issues to the highest levels within the provider's parent company.
- 3. Working to document by neighborhood what internet provider choices that neighborhood has.
- 4. Working to get ourselves educated on current laws affecting these services.
- 5. Engaged our state representative and state senator to get them educated as to our problems and work with them to craft legislation for change.

This problem is not unique to Fairview. Some of our neighboring Towns/Cities and most of the rural areas in the state suffer from poor internet service. Anywhere there is low housing density this happens because it is expensive for the providers to build out their networks for so few potential customers. My opinion is that internet service needs to be viewed and regulated as a utility service. We will see how many state/federal legislators I can convince.

A couple of ways you can help us document problems:

- 1. If you have an outage, obviously notify the provider and follow their process for getting service issues addressed. Also send an email to Assistant to the Town Manager, Adam Wilbourn at AWilbourn@FairviewTexas.org letting him know about it. Include your home address and phone number.
- 2. Check your speed of service by going to https://SpeedTest.FairviewTexas.org
- 3. If you are paying for some service level and not realizing the speed that you are paying for, please notify the provider so they can ensure

your issue is resolved. Also, send an email to Adam Wilbourn letting him know about the issue you reported to your provider. Let Adam know your home address and phone number as well.

I want to emphasize; Adam is not going to solve or track the problem; but we need to compile a documented record of problems to use as evidence when we talk with legislators. It is also important that service issues are reported to providers by residents so documentation is created in the provider's records as well.

Our Technology Committee under the leadership of John Adler will be working with me and Adam to try and do what is necessary to improve internet service in our Town.

Other things going on around Town.

**Peanut Butter contest:** This contest between the Collin County mayors benefiting the North Texas Food Bank was a success. As of press time we had collected more than 206 pounds of peanut butter. The contest is based on pounds of peanut butter collected per resident and Fairview is currently in first place! WellIlll – I think that was because I was first area mayor to turn any peanut butter in. Once we get the final results in, we'll let you know how well we did.

**Lock your vehicles:** Unfortunately, we have had a number of vehicle break-ins recently. These were not really break-ins as the vehicles were all unlocked sitting in the residents' driveways at night. Fairview is an extremely safe, low crime Town; but don't tempt someone – maybe a neighborhood kid – by leaving your vehicles unlocked overnight. Lock up at night and move anything in the vehicle to an out of sight position. A handgun that was in plain sight was stolen out of one of the vehicles.

As always, I end with a reminder to support our local non-profits that are taking care of those most impacted by Covid-19. Donations of any size are very welcome and you might help someone feed their kids or enable them to stay in their apartment. Look at Allen Community Out Reach, North Texas Food Bank, Veterans Center of North Texas, Shiloh House, Treasured Vessels; the need is great. I would also encourage you to support Fairview businesses. There are multiple restaurants open in the Fairview Town Center (FTC) and in the strip center along Stacy. For entertainment, the Fairview Youth Theatre in the FTC has multiple youth performances scheduled every weekend. The FTC also has outdoor, live entertainment every Friday and Saturday evening.

Residents who are registered voters with a "valid from" date of registration on or before November 3, 2020 may vote at any of the listed early voting locations or Election Day voting centers that are open under full contract services with the Collin County Elections Administration. The chart below lists early voting dates and hours of operation.

**Early Voting** will begin in Collin County on Tuesday, October 13 and end on Friday, October 30.

**Election Day Voting** will take place at Fairview Town Hall at 372 Town Place on Tuesday, November 3 from 7:00 a.m. to 7:00 p.m. *Early Voting will not take place at Town Hall*.

ach October people and organizations all over the world

participate in various events in honor of Breast Cancer Awareness month. Thousands of organizations use this time to increase awareness of breast cancer and to raise funds for research into its cause, prevention, diagnosis, treatment and cure. Major breast cancer charities, including Susan G. Komen and the American Cancer Society, host fundraising events as well as programs aimed at educating people about the importance of breast awareness, education and early screening.

Breast Cancer Awareness month was founded in October 1985 as a partnership between the American Cancer Society and AstraZeneca to promote mammography as the most effective weapon in the fight against breast cancer.

Kicking off the events in the Dallas area is Drummathon on October 4, 2020 hosted by local resident and founder of Breast Cancer Can Stick It! April Samuels. This year's Drummathon, will be a Virtual Live Stream and can be viewed from anywhere in the world.

In October 2010, April, a professional drummer, was diagnosed with an aggressive form of breast cancer called triple negative breast cancer. Immediately, April was motivated to "do something." The following month combining her will to fight breast cancer with her passion for drumming, she came up with the motto "Breast Cancer Can Stick It!"

became a **MONTH** brand and then officially a non-profit organization working to raise awareness and funds for research, clinical trials and a cure for breast cancer. Over the past eight years April and her organization have raised more than \$200,000 for the cause.

As Drummathon works to fight breast cancer, it is also a celebration of life, music and passion! Registered drummers for the event showcase their talent in front of family, friends and attendees during a timed drum solo, and then later, drummers and attendees have the opportunity to play on a kit alongside the celebrity drummers. And, since Breast Cancer Can Stick It! founder April Samuels is endorsed by the drum company owned and founded by Rikki Rockett of Poison/Devil City Angels, drummers will be playing on one of the two available Official custom Breast Cancer Can Stick It! drum sets designed by Rockett Drum Works.

The event will include an auction via eBay and will open September 29 and will end immediately following the Drummathon on October 4 at 9 p.m. Leading up to the event, drummers, musicians, and friends alike will register to raise funds online to compete for a plethora of awesome prizes.

## FAIRVIEW FIRE STATION NO. 1 CONSTRUCTION UPDATE

As of press time (September 2) inground utility work has been done as well as the installation of the foundation piers. Fiber reinforced concrete foundation beams have been poured and set. The under-slab mechanical, electrical and plumbing have been set up and installed. The parking lot is scheduled to begin as well but they were dealing with a rain delay.



Every year in October the National Fire Protection Association (NFPA) along with local fire departments host Fire Prevention Week (FPW). This year's FPW campaign, "Serve Up Fire Safety in the Kitchen!" will be held October 4-10. The campaign works to educate about the simple but important actions they can take to keep themselves, and those around them, safe in the kitchen. Did you know Cooking is the #1 cause of home fires and home fire injuries? Unattended cooking is the leading cause of fires in the kitchen.

Before you serve a meal, it's essential to serve up fire safety in the kitchen. There's nothing like spending time in the kitchen cooking a delicious meal for family and friends or an appetizing treat for yourself. But do you know the important steps to take long before anyone takes the first bite?

- Plan Your Escape Route
- Test Your Smoke Alarms
- Choose an Outside Meeting Place
- Make a Regular Reminder
- Practice Home Fire Drills

Since 1922, the NFPA has sponsored the public observance of Fire Prevention Week. In 1925, President Calvin Coolidge proclaimed Fire Prevention Week a national observance, making it the longest-running public health observance in the country. During Fire Prevention Week, children, adults, and teachers learn how to stay safe in case of a fire. Firefighters provide lifesaving public education in an effort to drastically decrease casualties caused by fires.

Fire Prevention Week is observed each year during the week of October 9th in commemoration of the Great Chicago Fire, which began on October 8, 1871, and caused devastating damage. This horrific fire killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures and burned more than 2,000 acres of land.

In a fire, mere seconds can mean the difference between a safe escape and a tragedy. Fire safety education isn't just for school children. Teenagers, adults, and the elderly are also at risk in fires, making it important for every member of the community to take some time every October during Fire Prevention Week to make sure they understand how to stay safe in case of a fire.

According to NFPA children under 5 and adults over 65 are at the highest risk for injury or death in a fire; however, people of all ages are vulnerable. In fact, the risk of a nonfatal fire injury is highest for those between 20 and 49, showing that fire safety education is essential for everyone.

The purpose of Fire Prevention Week is to bring awareness to the risk of death in case of a fire and provide educational resources for everyone. Visit NFPA.org/Public-Education to learn more about staying safe.

## 14th Annual Halloween at the Heard: A Family Fun Night Fundraiser

On Saturday, October 17, from 6:30 p.m. to 10 p.m., visitors from across North Texas will experience Collin County's premier family-friendly Halloween event at Heard Natural Science Museum & Wildlife Sanctuary. Halloween at the Heard features a safe environment to experience the joy of trick-or-treating along the eerie Dinosaurs Live! Live-Size Animatronic Dinosaurs trail. While ticket availability is always limited, this year, they will further reduce availability to allow for improved social distancing.

Families will enjoy an evening of fun activities including a presentation of a



family-friendly movie on the Heard' outdoor amphitheater stage. Those who dare will be able take a trail detour through our "Ghost Town"! Guests can also take a photo in their costumes at our fun photo ops. The Heard recommends that guests bring insect repellant, flashlights, water-resistant blankets and/or stadium seats for use during the movie. Drinks and refreshments will be available for purchase.

Tickets will be available to the public beginning October 2, while supplies last. Tickets for this annual event sold out over a week before the event last year, so the Heard encourages guests to purchase theirs as soon as possible. Admission to this event is \$15 for adults, \$10 for children ages 3-12, and free for children ages 2 and under. See HeardMuseum.org for more details.

#### About Heard Natural Science Museum & Wildlife Sanctuary

Proceeds from this event benefit Heard Natural Science Museum & Wildlife Sanctuary, a private 501(c)3 organization. The Heard was founded in 1967 by Bessie Heard. Miss Heard was 80 years old when she saw the need to preserve a place where future generations could experience nature. Today, the Heard's mission of bringing nature and people together is carried out through education, particularly of young people, which emphasizes an appreciation of nature and its conservation.

#### **Note Regarding COVID-19 Safety Protocols**

# Safety Tips

While Trick-or-Treating might look a little different this year because of COVID-19 we can still use some practical reminders to keep everyone safe.

#### **Child Safety**

- Never eat any treats until they are examined by an adult at your home.
- Never Trick-or-Treat alone. Go with friends or a
- Never enter the house or car of a stranger.
- Always Trick-or-Treat before dark.
- Trick-or-Treat in your own neighborhood and visit houses that you know.
- Stay on streets that are well lit and cross the street at corners.
- Never run across the street and ALWAYS look both ways before crossing.
  - Never take short cuts through backyards, alleys or
- Carry a flashlight so you can see hazards and wear reflective tape so drivers can see you.
  - Only Trick-or-Treat at houses that are well lit and that have a porch light on.
  - Do not let children use sharp tools to carve pumpkins. Allow children to draw faces on pumpkins with markers and then have the adults cut them.

#### **Adult Safety**

- Only buy flame resistant costumes, wigs, masks, etc., for you and your children.
- Only buy accessories like knives and swords that are made of soft, flexible materials.
- Welcome Trick-or-Treaters by turning on your porch
- Candlelit jack-o'-lanterns should be kept clear of doorsteps and walk paths.
- Consider using flashlights to light up your jack-o'lanterns, instead of candles.

- Keep pets away from the door, so children do not become frightened.
- Set a time limit for your children to Trick-or-Treat and designate a specific route.
- Feed children before they go, so they will be less likely to eat the treats before getting home.
- Carefully inspect all treats before allowing young children to start eating them.
- Use extreme caution when driving children around. Watch out for children walking in roadways or darting across the street.
- Backing vehicles account for a number of injuries on Halloween, so back up carefully.

#### **Pet Safety**

- In case of teenage pranks, do not leave pets outside on Halloween.
- Remember, chocolate, tin foil and/or candy wrappers can be very harmful or toxic to some pets.
- Pets may knock over lit candles and pumpkins and start fires or get burned.
- Dressing pets in costumes can cause undue stress on animals.
- Keep pets in a separate room from where Trick-or-Treaters will visit.
- Pets can be unpredictable around people dressed in costumes. Someone could be bitten.
- Pets may run to the door or dart out the door when Trick-or-Treaters come knockina.
- Walk your dog before the Trick-or-Treaters come out to avoid accidental encounters.



#### Remember These Simple Guidelines For Putting Your Trash Out

- 1. Place carts on the edge of the street/alley with handles facing the house and with the lids opening to the street/alley.
- 2. Keep carts two to three feet apart and away from fences, cars, gates, gas meters, etc...
- 3. All trash should be contained in securely tied plastic bags. All bags should fit into the cart with the lid closed.
- 4. Do not place hazardous household waste in your cart.
- 5. Place your carts out by 7 a.m. on pick up day; carts should not be left out after 6 a.m. the following day.
- 6. Do not place any items out side your carts; unless it's for bulk pick up.
- 7. Brush and bulk trash must not be more than 12 cubic yards which is equal to 4 truck loads.
