Stacy Road Update

The Stacy Road project is finally coming to a close. The last few sidewalks and new traffic lighting poles at Stacy and Angel Parkway have been set and are functioning well. Eastbound Stacy at S.H. 5 has been restriped to give drivers more time to merge. TxDOT is will conduct a traffic study that they will use to determine new speed limits on Stacy Road.

In the meantime, Fairview officers have been enforcing the old speed limit of 50 mph. TxDOT does not pay for landscaping of the medians or street lighting, so they were not included in this project. Allen and Fairview would have to split construction and maintenance costs of any new trees or landscaping, irrigation systems or street lighting in the future. Fairview and Allen will continue discussing future landscaping, with the understanding that the wide median will be narrowed some day when the 2 inside lanes are installed as traffic demand warrants.

Grand Opening of Republic Services Recycling Center

The latest example of Republic Services ongoing commitment to sustainable practices and investment in recycling facility processing capabilities and technologies in their “Next Gen” Plano Recycling Center. The new Plano Recycling Center began full operations in late January 2019 and serves more than 500,000 residents and 2,500 commercial customers throughout Plano, Fairview, Richardson and other neighboring towns.

The 76,000 square foot facility is capable of processing approximately 350 tons of recyclable material per day, or about 35 tons per hour with only 35 employees. All of this equates to saving 550,000 trees and 215 million gallons of water each year.

Republic Services’ commitment to sustainable practices extends throughout their operations and into their recycling facilities. When designing and building the new facility they adhered to the U.S. Green Building Council’s Leadership in Energy and Environmental Design (LEED) standards. This included using sustainable materials to facilitate energy



and water conservation as well as design principles that enhance employee and guest comfort. With these standards at the forefront of Republic’s facility projects they are making work spaces more environmentally responsible and productive.

On average, recycling contamination levels are at 30 percent, which means the separation of clean recyclables from

contaminated material is more important than ever. The Plano facility uses highly advanced sorting technologies to process 350 tons of recyclable material per day - separating material in milliseconds. This includes optical sorters, next-generation anti-wrap fiber screens, magnets and other innovative techniques. Additionally, an automated, touch screen control system and tablet based capabilities allow for real-time systems management and monitoring, data acquisition and remote access from anywhere in the world.

The Plano Center also includes a first-of-its-kind, interactive Learning Center designed to educate consumers about recycling. Visitors of all ages can get a first-hand view of the 16-step recycling process from the observation deck, view recycling videos and sustainability educational videos and displays. Visitors can also play interactive games throughout the 5,000 square foot learning space. The Learning Center serves as an important community resource helping to educate visitors of all ages – with a distinct focus on youth – on ways to become better recyclers. Autism Awareness Month

At the April Town Council Meeting Mayor Darion Culbertson declared the month of April as Autism Awareness Month in the Town of Fairview.

Autism spectrum disorder (ASD) is a neurological and developmental disorder that begins in early childhood and lasts throughout a person's life. It affects how a person acts and interacts with others, communicates and learns. Many of our residents in the Town of Fairview have Autism and are valued members of our community who are our family, neighbors, classmates and coworkers who make significant contributions to society.

Mayor Culbertson said, "It is vital that the town continues to make it a priority to join with these individuals and their families in providing care and support as well as partnering with local nonprofits that specialize in this care." One such organi-

zation is Cornerstone Ranch, whose staff and residents were on hand to lead the Pledge of Allegiance at the beginning of the meeting and to accept the proclamation.

Located on 42 acres just south of the Fairview Soccer Complex; Cornerstone Ranch is a group home that creates meaningful activities to empower adults with special needs to live the abundant life they were created for, realizing their God-given potential and celebrating their miraculous lives. Cornerstone's 10,000 square foot residential home comfortably accommodates seven adults with disabilities, as well as two highly integrated care giving families. The activity center houses all the day programs and enrichment activities for all the adults in their programs.

honor and support the efforts of individuals with developmental disabilities, as well as their families, teachers, churches, and the local nonprofits who sup-

Red Thumb Awareness Day

Distracted driving is quickly becoming one of the most common causes of motor vehicle accidents, often resulting in serious injuries or fatalities and, at any given moment across the U.S., approximately 660,000 drivers are using cell phones or manipulating electronic devices while driving, a number that has held steady since 2010, according to the Federal Communications Commission.

Texting while driving combines all three forms of driving distractions; visual, manual and cognitive. In 2015, with safety as a top priority, the North Texas Tollway Authority (NTTA) joined a nationwide campaign aimed at raising awareness to end texting and driving. The movement encourages drivers to make some part of their thumbs red to remind them to keep their



hands on the wheel and eyes on the road at all times.

In conjunction with more than 40 municipal (including Fairview), transportation and community partners more than 140,000 small Red Thumb bands emblazoned with "W82TXT" have been placed on driver's thumbs as a visual reminder to avoid distracted driving.

The NTTA, along with its community partners, is asking drivers to take accountability and stop their dangerous behavior behind the wheel and remember the fight to end distracted driving starts with you. At the April Town Council Meeting Mayor Culbertson proclaimed April 23, 2019 as Red Thumb Day in the Town of Fairview. The Town of Fairview joins in solidarity with NTTA to discourage distracted driving and to urge everyone to remember to W82TXT.

PROCLAMATIONS

Sexual Assault Awareness and Prevention Month

The Turning Point Rape Crisis Center; whose mission is to provide counseling, education and advocacy for those impacted by sexual violence; attended the April Town Council Meeting to accept a proclamation from Mayor Culbertson proclaiming April as Sexual Assault Awareness and Prevention Month in the Town of Fairview.

Sexual Assault Awareness and Prevention Month is intended to draw attention to the fact that sexual violence is widespread and impacts every community member of Fairview. Rape, sexual assault and sexual harassment impact our community and statistics for Texas show two in five women and one in five men have been sexually assaulted at some point in their lives.

The Town Council along with Mayor Culbertson also agree that child sexual abuse prevention must be a priority to confront the reality that one in six boys and one in four girls will experience a sexual assault

before the age 18. Young people experience heightened rates of sexual violence, and youth ages 12-17 were 2.5 times as likely to be victims of rape or sexual assault.

Mayor Culbertson said, "We must work together to educate our community about sexual violence prevention, supporting survivors and speaking out against harmful attitudes and actions. With leadership and dedication, we can be successful in preventing sexual violence in Fairview by increasing education, awareness and community involvement."

Together with the Turning Point Rape Crisis Center of Collin County the Town of Fairview strongly supports the efforts of national, state and local partners, and of every citizen, to actively engage in public and private efforts to prevent sexual violence and to start conversations to support one another and create a safer environment for all.

TRAVELING WORLD WAR I EXHIBIT MAKES STOP IN FAIRVIEW

Lest We Forget, a traveling World War I exhibit, will make several stops in North Texas, including Fairview on June 6, 2019 at Heritage Ranch Golf and Country Club. The event is free and open to the public.

The exhibit has welcomed more than 175,000 visitors since the 2014 ribbon cutting at Frontiers of Flight Museum, commemorating the centennial anniversary of World War I which began in 1914 and concluded in 1918.

The North Texas tour held a kick off on April 27 in McKinney and included a fly-by of WWI bi-planes from the Cavanaugh Flight Museum. Exhibit curator, Keith Colley said,

“We wanted to share this with North Texas because we believe it’s important to honor and remember the veterans who were a part of this world conflict.”

The World War I Mobile Museum is a traveling exhibit of more than 200 original artifacts composed of twelve sections depicting different themes, such as trench warfare, photographic and cinematic treatment of the war and Christmastime



on the battlefield. Artifacts include personal items used by soldiers, one of the first battlefield movie cameras and an authentic trenching tool used to dig more than

25,000 miles of trenches during the war.

“When I was visiting the National World War I Museum in Kansas City, I realized our senior adults are the last direct descendants of World War I veterans and decided to create a mobile museum to bring the museum to them wherever they live,” said Colley.

The hope is to keep the memory of World War I and its veterans alive, which is why it’s called “Lest We Forget,” a phrase that

comes from a speech delivered by President Woodrow Wilson after the war ended.

“Although World War I was 100 years ago, still many people today had family and friends who served in the war and feel strongly connected to the veterans. That is the purpose for the museum; to engage our community,” says Colley.

History of Father's Day

While a presidential proclamation declaring the third Sunday of June as Father's Day wasn't signed until 1966 by President Lyndon Johnson many scholars believe Father's Day has been celebrated around the world for centuries and can be traced back to the ruins of Babylon. Archaeologists uncovered a carved message from a boy to his father wishing him good health and a long life.

There are many theories as to who first came up with the idea of celebrating Father's Day, but most historians believe the modern day celebration, as we know it in the United States, can be attributed to Sonora Louise Smart Dodd. She was listening to a Mother's Day sermon in 1909. Sonora was close with her father, William Smart, and wondered why there wasn't a day to celebrate fathers.

Inspired by the woman behind Mother's Day, Anna Jarvis, Sonora started a campaign to celebrate the first Father's Day. She worked with the Spokane Ministerial Association and the YMCA and together they held the first Father's Day Celebration on June 19, 1910. Over the next five years Father's Day

celebrations gained popularity across the U.S.

Seeing the growth of Father's Day, President Woodrow Wilson got on board and supported the holiday in 1916 with President Coolidge supporting the idea as well in 1924 to, "establish more intimate relations between fathers and their children and to impress upon fathers the full measure of their obligations." And, it was in 1972 that President Nixon established a permanent national observance of Father's Day to be held on the third Sunday of June.

Over the years Father's Day celebrations have grown all over the world and is considered a secular holiday. However, in countries where the Catholic Church holds greater influence, Father's Day is celebrated on March 19 which is the Feast of Saint Joseph.

Town Quarterly Financial Report

For Quarter Ending March 31, 2019

Monthly financial reports are prepared for the General Fund, Water and Wastewater Fund, Solid Waste Fund, Debt Service Fund, Stormwater Fund and Fairview EDC/CDC Funds, these reports are presented to the Town Council at their monthly meetings. These monthly financials can be accessed on FairviewTexas.org by selecting Departments/Administration/Audit-Budget.

This report covers through March 31, 2019, which is the end of the second quarter of fiscal year 2018-2019; therefore, it is generally desirable for year-to-date revenue totals to have achieved 50 percent of the budgeted amount and expenditures should generally not exceed 50 percent of the budgeted amounts. However, because property taxes are primarily received during the first trimester of the budget year and other revenues such as franchise fees are cyclical, revenues will not always equate to the projected percentage. Likewise, total expenditures may not always equate to the projected percentage, because payments for contracted services, insurance and debt service payments are paid in lump sum amounts, while transfers to other funds occur quarterly.

General Fund Analysis

Revenue collections in the General Fund for the sixth month of fiscal year 2019 total \$6,551,054 and represent 72.7 percent of the total annual budget. Actual total collection this year is \$237,987 more than last year, primarily due to Investment income, Sales Tax and Franchise fees collected increasing from prior year.

General Fund expenditures total \$4,302,628 and represent 47.5 percent of the total annual budget. Expenditures are \$285,958 more than the previous year. All other expenditures for all divisions are within the acceptable range.

Water and Wastewater Fund Analysis

The Water and Sewer Fund revenues total \$1,746,928 and represent 26.7 percent of the total annual budget. This amount is \$672,877 less than last year. Water sales were lower by \$643,064 and sewer sales increased by \$10,046 than the previous year.

Expenses for the Water and Sewer Fund total \$2,860,359 and represent 42.5 percent of the annual budget. This amount is \$209,339 more than prior year.

Other Funds Analysis

The revenues and expenditures for all the other operating funds are within an acceptable percentage range. Revenues and expenditures will be monitored and reported to ensure that spending will not exceed the approved budget amounts.

Sales Tax Analysis

Sales tax revenue collections for the entire Town of Fairview (Town, Fairview EDC and Fairview CDC portions) for the sixth month of fiscal year 2019 total \$1,992,682. Actual total collection this year is \$169,166 or 9.3 percent higher than last year.

The Town of Fairview received \$200,858 in sales tax revenue during the month of March 2019. This amount represents a decrease of \$2,411 or 1.2 percent less than March 2018. Due to the timing, the sales tax received in the month of April 2019 can be reported in this financial report too. The Town of Fairview received \$222,650 during the month of April 2019. This amount represents an increase of \$20,834 or 10.3 percent more than April 2018.

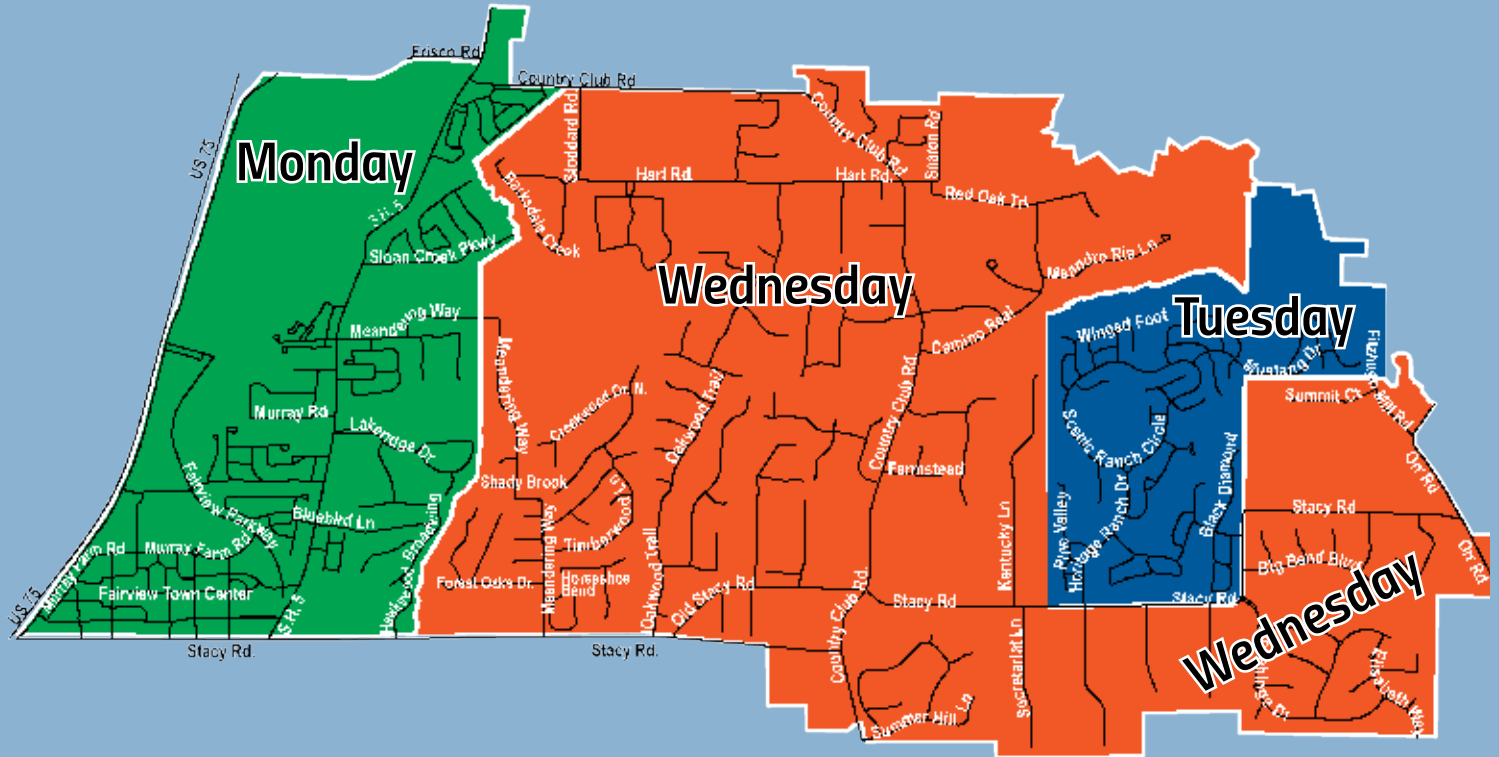

handicap parking spot. There is also plenty of room to park on the street.

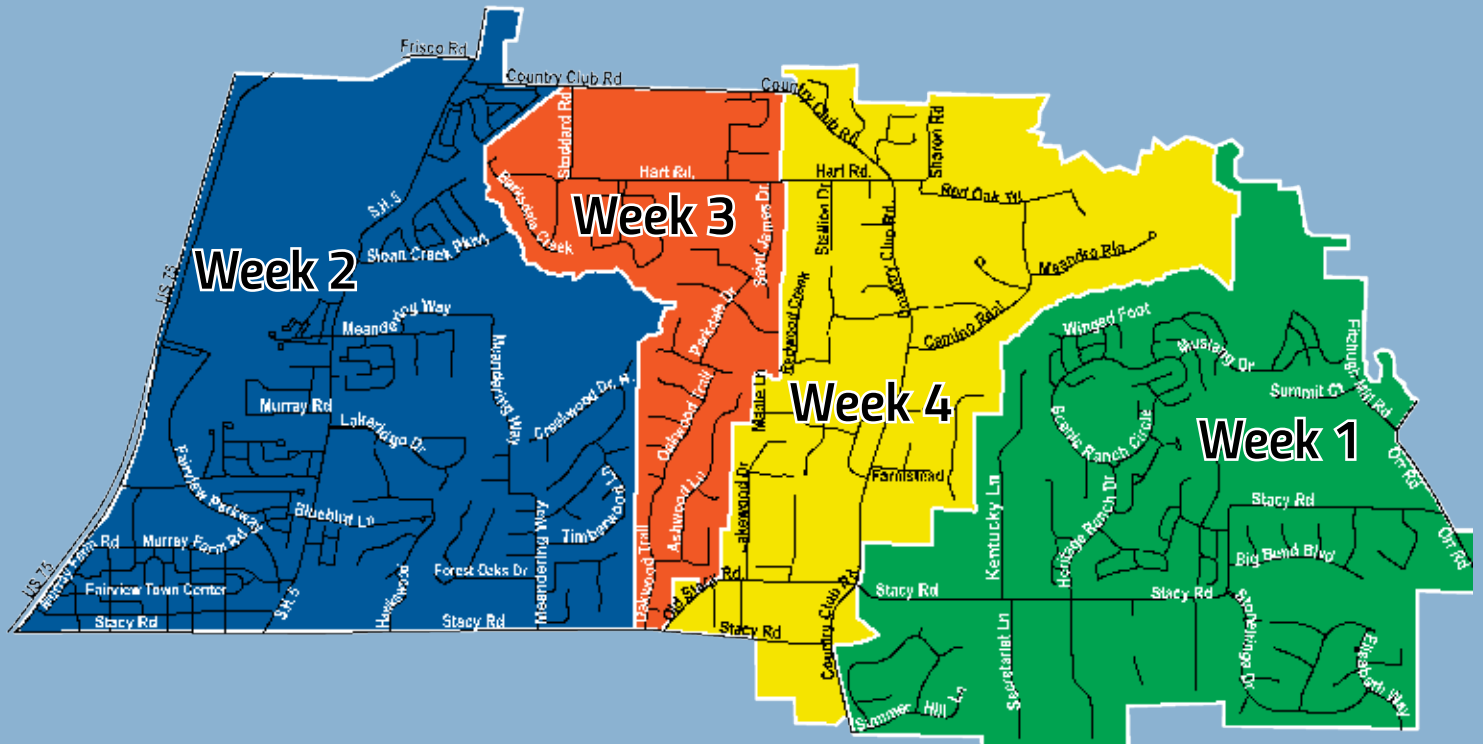

Remember These Simple Guidelines For Putting Your Trash Out

1. Place carts on the edge of the street/alley with handles facing the house and with the lids opening to the street/alley.
2. Keep carts two to three feet apart and away from fences, cars, gates, gas meters, etc...
3. All trash should be contained in securely tied plastic bags, All bags should fit into the cart with the lid closed.
4. Do not place hazardous household waste in your cart.
5. Place your carts out by 7 a.m. on pick up day; carts should not be left out after 6 a.m. the following day.
6. Do not place any items out side your carts; unless it's for bulk pick up.
7. Brush and bulk trash must not be more than 12 cubic yards which is equal to 4 truck loads.

Native Texas Butterfly House and Garden at Heard Museum Reopens June 1

From June 1 through September 30, 2019, visitors to the Native Texas Butterfly House and Garden at Heard Natural Science Museum & Wildlife Sanctuary in McKinney, Texas will have the opportunity to walk among free-flying native butterflies and other pollinators. Guests will be able to view butterflies up close while learning about their life stages, migration and survival strategies.

The butterfly house is regularly stocked with an assortment of native butterfly species, which varies throughout the exhibit. Guests may even get to see a butterfly emerge from a chrysalis. Inside the butterfly house, nectar



plants are also available to feed the adult butterflies. There are even a few host plants for caterpillars to feed on ("host plants").

The butterfly garden, too, is filled with nectar plants and host plants that naturally attract these lovely creatures. Guests may even find a few ideas to try in home gardens, which can in turn help pollinators on a broader scale. From time to time, other species of wildlife that feed on insects or the nectar plants may also be



found in the butterfly garden, including hummingbirds. This area is also a great setting for nature photography.

The Native Texas Butterfly House and Garden is included in museum general admission
