TxDOT is allowing traffic to drive on Stacy Road's southern lanes with intermittent lane closures for construction. There will be times that the lanes closest to the median are open, during which time the outside lanes near the sidewalks will be open while they do work near the medians. There will be some traffic signalization work to convert the span wire signals over to mast/arm poles. The project is nearing completion and we want to thank everyone for their patience.

FAIRVIEW PARKS AND TRAIL SYSTEM



Because the Town of Fairview is dedicated to developing a town with open spaces and beautiful park land Town Council, Parks Board and Town staff have worked tirelessly throughout the years to develop and continually update our Parks and Recreation Master Plan. And, in an effort for the Town to communicate with residents about our parks and their facilities the Fairview Town News will begin highlighting a different park each month beginning with this brief history of the parks and trail system.

The original Master Plan was conceived and developed in 1995 and is updated approximately every five years. In 2005, the Town worked with independent consultants in conjunction with updating the Town's Comprehensive Plan. At that time Fairview had an estimated population of 4,720 and it was projected to reach 5,000 by the end of the year. Fairview also only had one completed park at the time; Creekside in Oakwood (Beaver Run in Thompson Springs was still in the planning stages).

The updated plan called for parks in Thompson Springs, Summerhill Farms, Murray Farm, Sloan Creek Estates (trail and open spaces), a 95-acre sports park (Fairview Soccer Complex), Town Center as well as various open spaces. Additionally, the Plan recommended eight additional neighborhood parks within the Town limit.

In 2010, the Plan was once again updated, this time the effort was led by the Parks Board in conjunction with Town staff. The update kicked off with a survey mailed to each of the 2,724 Fairview water account addresses. The results of the survey showed that respondents overwhelmingly favored trails and natural areas. Neighborhood parks and a large community park were a distant third and fourth in respondent preferences.

During the 2010 update the inventory of parks showed that a number of proposed projects from the 2005 Plan update had been completed. Some of these were funded by the Town while several were primarily funded by development. Town funded parks include



Beaver Run, Monarch Park, Cypress Park, Roadrunner Trail, Sloan Creek trail and greenspace and Veterans Park. Those funded by development were; The Village Green (funded primarily by MGHerring), The Meadows (funded primarily by Grenadier Homes) and Fairview Soccer Complex (funded by Ayses Soccer Club).

The 2010 Plan update envisioned the 83 acres owned by the Town (south of McKinney National Airport) as a future community park. Additional goals from the Plan were to acquire open spaces, greenbelt land and neighborhood park land as opportunities and development allowed. The Plan also called for improvements to existing facilities - a trail to connect Orr Road to the Army Corps of Engineer land, amenities in Coyote Park, pavilions in Cypress Park and a nature trail on the west side of Creekside Park.

Many projects have been completed in the years since the 2010 update – the Town acquired 30 acres of greenspace, a trail & a connector bridge over Sloan Creek; open space, a connector trail & money escrowed for a connecting bridge over Wilson Creek; trail & a water detention area from Apple Crossing and a trail, open space & land for trailhead parking from Parkside. Additionally, the Town funded improvements to parks including: a pavilion, landscaping, playground turf, benches & a grill in Cypress Park; a playground with turf, pavilion, grill, benches, a sports court & landscaping in The Meadows and playground turf in Monarch Park. The current update of the Plan is once again being led by the Parks Board and Town staff. The Parks Board has spent time reviewing the previous plan, accomplishments since the last update and the Town's current trail system. They are also working diligently to find ways to connect trails while adhering to the section of the 2010 Plan that specifically addresses not using emergency access easements for trail connectors unless there is cooperation from neighbors. The result of reviewing the trail system is a proposed plan that uses existing road ways as trail connectors. This proposal will provide significant improvements in connecting various parts of the town.

In an effort to better understand the park and trail system the Park Board toured and reviewed all existing parks as well as general areas designated as future parks in the current adopted plan. This allowed Board members to make informed decisions about which potential park areas should remain in the Plan and which areas were no longer viable, based on the Town's development. They have created and ranked a list of proposed capital projects to be presented to the Town Council for their consideration, in a future joint meeting between the two bodies.

After finishing the framework for the updated Plan, Board members developed a survey to better gauge the desires and knowledge of Fairview residents regarding parks. The 2018 questionnaire was done online and was sent to more than 4,300 households. The results of the 2018 survey will be presented to the Town Council in a joint meeting.

Armed with this knowledge the Town Council together with the Parks Board will hold a public meeting that includes a public hearing component so citizens can provide input to the Parks Master Plan. After the public hearing, the plan will be finalized and presented to the Town Council at a public meeting, prior to adoption.


In the meantime we will feature various parks and trails that are available to the community as a whole.



Town Quarterly Financial Report For Quarter Ending December 31, 2018

Monthly financial reports are prepared for the General Fund, Water and Wastewater Fund, Solid Waste Fund, Debt Service Fund, Stormwater Fund and Fairview EDC/ CDC Funds, these reports are presented to the Town Council at their monthly meetings. These monthly financials can be accessed on FairviewTexas.org by selecting Departments/Administration/ Audit-Budget.

This report covers through December 31, 2018, which is the end of the first quarter of fiscal year 2018-2019; therefore, it is generally desirable for year-to-date revenue totals to have achieved 25 percent of the budgeted amount and expenditures should generally not exceed 25 percent of the budgeted amounts. However, because property taxes are primarily received during the first trimester of the budget year and other revenues such as franchise fees are cyclical, revenues will not always equate to the projected percentage. Likewise, total expenditures may not always equate to the projected percentage, because payments for contracted services, insurance and debt service payments are paid in lump sum amounts, while transfers to other funds occur quarterly.

General Fund Analysis

Revenue collections in the General Fund for the third month of fiscal year 2019 total \$2,811,767 and represent 31.2 percent of the total annual budget. Actual total collection this year is \$55,941 less than last year, primarily due to lease proceeds received prior year.

General Fund expenditures total \$2,231,694 and represent 24.7 percent of the total annual budget. Expenditures are \$149,522 more than the previous year. All other expenditures for all divisions are within the acceptable range.

During the Month of October and November, the majority of the revenues and expenditures received/expensed are related to the prior fiscal year; therefore, journal entries will be made to re-class revenue and expenditures actually received/spent in October and November 2018 to be recorded in September 2018 for audit purposes.

Water and Wastewater Fund Analysis

The Water and Sewer Fund revenues total \$1,167,623 and represent 18 percent of the total annual budget. This amount is \$178,606 less than last year. Water sales were lower by \$154,987 and sewer sales were lower by \$680 than the previous year.

Expenses for the Water and Sewer Fund total \$1,280,649 and represent 19 percent of the annual budget. This amount is \$478,525 less than prior year.

During the Month of October and November 2018, the majority of the revenues and expenses received/expensed are related to the prior fiscal year; therefore, journal entries will be made to re-class revenue and expenses actually received/ spent in October and November 2018 to be recorded in September 2018 for audit purposes.

Other Funds Analysis

The revenues and expenditures for all the other operating funds are within an acceptable percentage range. Revenues and expenditures will be monitored and reported to ensure that spending will not exceed the approved budget amounts.

Sales Tax Analysis

Sales tax revenue collections for the entire Town of Fairview (Town, Fairview EDC and Fairview CDC portions) for the third month of fiscal year 2019 total \$783,385. Actual total collection this year is \$8,708 or .01 percent higher than last year.

The Town of Fairview received \$236,825 in sales tax revenue during the month of December 2018. This amount represents an increase of \$43,239 or 22 percent more than December 2017. Due to the timing, the sales tax received in the month of January 2019 can be reported in this financial report too. The Town of Fairview received \$281,942 during the month of January 2019. This amount represents an increase of \$62,242 or 28.3 percent more than January 2018.

Alan Efrussy Week



At the January 2, 2019 Town Council Meeting, Mayor Culbertson issued a proclamation honoring former Planning Director, Alan Efrussy. And, declaring the week of January 7 as Alan Efrussy Week.

Mayor Culbertson began the proclamation with, "we are here today to express our appreciation to Alan Efrussy and honor him for his distinguished 51-year career as an Urban Planner and his dedicated

service in Urban Planning throughout municipal government."

Alan was born and raised in Chicago, Illinois where he attended the University of Illinois and received a Bachelor's degree in History; after which he joined the Navy and traveled a large majority of the Western



Hemisphere while serving on an aircraft carrier. His travels through various countries expanded his interest of history into an interest in the greater history of cities themselves and stimulated an interest in redevelopment and rehabilitation of cities. Upon his completion of duty he enrolled in Roosevelt University and received his Master's Degree in Urban Planning.

Alan's career began on August 9, 1967 as a Community Planner for the Chicago Regional Office of Housing and Urban Development servicing Illinois, Indiana, Michigan and Wisconsin within the Model Cities Program. Alan joined the Town of Fairview in October of 2002 as the Planning Director bringing with him a wealth of knowledge and experience gained from his time in Illinois and throughout the state of Texas.

Alan was instrumental in the adoption of the Town's first major Comprehensive and Park Plans; as well as helping to establish the policy of immediate zoning upon Town annexation to protect neighborhoods.

Mayor Culbertson expressed appreciation to Alan for, "his contributions to, not only the Town of Fairview, but to the surrounding areas as well." The Mayor also thanked him for the knowledge he has imparted throughout his career and wished him much happiness as he begins this exciting new chapter in his life.



Collection Schedules

Bulk trash may be put out after 6 p.m. on the Friday before collection but no later than 7 a.m. on Monday of your collection week. Bulk trash may be picked up anytime during the collection week.

2019 Holidays: Trash, recycling, bulk and brush will not be picked up on the holidays listed below; instead the collection will slide one day after the holiday.

Remember These Simple Guidelines For Putting Your Trash Out

- 1. Place carts on the edge of the street/alley with handles facing the house and with the lids opening to the street/alley.
- 2. Keep carts two to three feet apart and away from fences, cars, gates, gas meters, etc...
- 3. All trash should be contained in securely tied plastic bags, All bags should fit into the cart with the lid closed.
- 4. Do not place hazardous household waste in your cart.
- 5. Place your carts out by 7 a.m. on pick up day; carts should not be left out after 6 a.m. the following day.
- 6. Do not place any items out side your carts; unless it's for bulk pick up.
- 7. Brush and bulk trash must not be more than 12 cubic yards which is equal to 4 truck loads.

PRESCRIPTION DRUG TAKE BACK DAY



The Fairview Police Department is participating in the DEA's nationwide medication disposal program.

Saturday, April 27, 10 a.m. - 2 p.m. Fire Station #1, 500 S. State Highway 5 Medication can be disposed in its original container or by removing the medication from its container and disposing of it directly into the disposal box. Liquid products, such as cough syrup, should remain sealed in the original container. Caps must be tightly sealed to prevent leakage. Intra-venous solutions, injectables and syringes will not be accepted due to potential hazard posed by blood-borne pathogens.
