## DAYLIGHT SAVING SAFETY

Daylight Saving Time ends on Sunday, November 3 at 2:00 a.m. So, as we fall back an hour, it is important to realize that more joggers and cyclists will be on residential roads during night hours. Studies have found that car accidents go up after we turn the clocks back. In addition to decreased visibility, commuting in the dark makes drivers drowsier than usual. Below are some tips for staying safe both outside and on the road.

### TIPS FOR DRIVERS:

- As a driver, assume people are on the streets at all hours.
- Clean headlights, taillights, signal lights, mirror faces and windows once a week. Clean your windows on the inside and outside.
- Make sure headlights are properly aimed, misaimed headlights blind other drivers and reduce your ability to see the road.
- If there is any doubt of visibility, turn your headlights on. Remember that being seen is as important as seeing.
- Reduce your speed and increase your following distance at night.
- Avoid glare from oncoming bright headlights by watching the right edge of the road and using that as your steering guide.
- If you have car trouble, pull off the road as far as possible. Turn on emergency flashers and the interior dome light. Stay off the roadway and get passengers away from the area.

**TIP:**  
When you change your clocks, it is also a great time to remember to change the batteries in smoke alarms and carbon monoxide detectors.

### TIPS FOR PEDESTRIANS:

- Wear light colored clothing.
- Carry a small LED flashlight in your hand and point it at the ground as you travel. A quick wave of the light at any approaching car may get the driver's attention.
- Ensure bike safety reflectors and lights are working properly.
- Stay alert. If you use a headset, keep the volume low enough that you can still hear oncoming traffic.
- Remember that riding or running down the middle of the road puts you in harm's way and decreases reaction time.
- If you are uncomfortable with oncoming traffic, stop and step off the road and wait for vehicles to pass. Do not try to keep moving on dark or uneven ground.
- If you bring your dog(s) at night, keep them on a short leash in the presence of oncoming traffic.

# MESSAGE FROM THE MAYOR

## *Dear Neighbors,*

I'm pleased to report that the Town of Fairview's first annual peanut butter drive benefiting the North Texas Food Bank was a big success — we collected 238 pounds of peanut butter. Thanks to all who helped with the drive, especially Boy Scout Troop 358 and the Fairview Rotary Club.

As most of you have probably heard, Fairview Town Center has been attracting new tenants, with the most recent being Venture X, a membership workspace community that has been recognized in Inc. magazine as one of the best coworking companies in the United States. We look forward to welcoming Venture X in early 2020, when they are set to open the first dedicated office space in Fairview in nearly 20,000 square feet of repurposed space in the Fairview Town Center. This also will bring daytime workers to the FTC, which means more support for the retail stores and restaurants located there.

Just days after receiving the great news about Venture X came another announcement that has been many years in the making. The 242 acres at the southeast corner of U.S. 75 and State Hwy. 121 will be the home of a major mixed-use project developed by the Billingsley Company. The Petefish family, longtime owners of this property, has been looking at developers for more than 20 years. We certainly appreciate their cautious approach as there is no question that this Petefish-Billingsley joint venture is going to be top quality.

You might be familiar with the highly regarded Billingsley name from some of their previous DFW-area projects such as Austin Ranch in Plano, One Arts Plaza in the Dallas Arts District or Cypress Waters near DFW International Airport. Founded more than 40 years ago by Lucy and Henry Billingsley, this 41-year-old family-run development and property management company specializes in master-planned projects that maximize natural spaces, provide great amenities and enhance the communities where they are located. We could not have hoped for a better partner than the Billingsley Company for this highly desirable commercially zoned tract.

Speaking of zoning, previous Town Councils had the foresight to put in place “form-based” standards for this property, ensuring high quality and regulating key aspects of building and site design. It's important to keep in mind that the visionary decisions made in the 1970s to have low-density residential in much of Fairview also required commercial development in the U.S. 75 corridor to help financially support the infrastructure for the homeowners. We are now seeing that long-term strategy coming to fruition.

I have been pleased to discover during my discussions with the Billingsleys that their vision for this space mirrors our own, from their respect for the land and its beautiful resources to their goal of offering a great place to live, work and enjoy evenings and weekends.

The Billingsley Company has a reputation for bringing major corporations to their developments, which in turn will bring the residents, whose presence will bring the amenities that we can all enjoy having nearby.

While it is way too soon to know exactly what will be built in this space, we do know that our Dark Sky ordinance will be honored, building height is restricted and the new buildings will actually act as a noise and light barrier to U.S. 75 once they are complete.


This development is a big deal for our town, and a big financial win. The project has the potential to increase Fairview's property tax base by \$1 billion — in other words, a potential 50 percent increase over our current valuation. We will also see sales and beverage tax revenues generated by the retail and restaurants that will locate in this new development.

## FIRE SAFETY

The holiday season is quickly approaching and the Fairview Fire Department would like to remind you of a few fire safety tips for while you are working in the kitchen this Thanksgiving:

- Always call 911 immediately if a fire occurs.
- Don't cook food overnight in the oven or on the stovetop.
- Don't leave a stove unattended while cooking.
- Keep children away from hot stovetops and flammable items, spills can cause burns and kitchen fires.
- Don't wear long sleeve clothing when cooking near an open flame.
- Never use water to extinguish a grease fire.
- If a fire ignites in the oven, keep the door closed and turn the heat source off.
- Ensure turkeys are fully thawed before frying; never deep-fry a *frozen* turkey.
- Always keep a fire extinguisher handy while deep-frying a turkey.
- Be careful not to overfill a turkey pot with oil or grease.

Their main goal is to provide comprehensive, accessible, free services for 100 percent of children and families in Collin County impacted by or at risk of child abuse or neglect.

CCFK is a free to enter event; however; organizers ask attendees to donate a new, unwrapped toy for the toy drive. There are costs associated with children's activities, however, all the proceeds will benefit the Children's Advocacy Center.

# HERITAGE RANCH THEATRE GUILD



**D**id you know Heritage Ranch is home to a theatre troupe? The Heritage Ranch Theatre Guild (HRTG) was founded in 2006, by a collection of neighbors who attended a six week acting course taught by Rozelle Gillman of Collin County Community College. After taking the class the group performed a series of skits in the Corral Grill including, “The Diary of Adam and Eve”, “Free to Be You and Me” and “The South Paw”. Shortly after that first performance the Guild was officially formed with 11 founding members.

In March 2007, the Guild performed a play written by Heritage Ranch resident, Jerri Clements and directed by Flo Hooker. The play was set in the Courtroom of the Town of Fairview and was titled “The Great Robbery” or “How I Got Hosed”. By that time the Guild had added 14 new members. And, following the success of that show the Guild staged their first full scale production in the HR Ballroom, “Twelve Angry Jurors”. Since then, the Guild produces two full scale productions each year.

In June 2015, the Guild launched a new initiative, a reader’s theater production. The one night only performance consisted of three short plays and one radio play, “The Lone Ranger”. The scripts were read by the actors without sets or props and were very well received by the more than 120 residents and guests who attended this free performance. Since that time, there has been a Reader’s Theatre play each year as part of the Theatre Guild performance schedule.

Just in time for the holidays the HRTG will present this year’s Reader’s Theatre on November 20, 21 and 22, from 7:00 to 8:30 p.m. “Thank You Notes for the 12 Gifts of Christmas,” is a 20-minute skit that will be sung and read. The second, “When Christmas Left Rattler Canyon,” is a one-hour melodrama set in a 1800’s West Texas saloon. There will be costumes, sound effects and sets – and lots of laughs. All HRTG productions are open to the public.

“Both types of performances, Reader’s Theatre and traditional plays, draw enthusiastic reviews, and there is growing interest in our Reader’s Theatre,” said Jim Dill, current treasurer of the HRTG and an original founding member. “We hear that audiences always find it fun to see their neighbors perform and the actors can be a little more spontaneous in the Reader’s Theatre productions. Plus, the Guild is a fun place to bring out your skills from high school, college or past theatre groups.”

Longtime HRTG member and current vice president Liz Glasco agrees, saying Reader’s Theatre is great way to flex your inner thespian if you are a little rusty or have a busy schedule. “In particular, Reader’s Theatre usually requires no memorization, and the productions are generally comedies, mysteries or melodramas,” she said. “Regardless, all our productions provide great entertainment value, although we do vary the tone and genre to keep our performances from being cookie cutter and to attract players with different abilities.”

Besides marking your calendar for November’s performance, look for announcements about the Spring 2020 production, “Suite Surrender”, a comedy set in 1942, when two of Hollywood’s biggest divas descend on the Palm Beach Royale Hotel, complete with large egos and entourages, only to find themselves booked into the same suite.

HRTG is a volunteer run organization and they could always use more volunteers to help with set build, costuming, front of house tasks, photography and back stage tasks. ## TEXAS HEALTH ALLEN EXPANSION PROJECTS KEEP CONSUMERS IN MIND



Texas Health Presbyterian Hospital Allen is growing to meet the needs of the community. The hospital, which opened in 2000, is currently undergoing the largest expansion in its history, a project that will add 75 beds and space for a variety of service lines. The \$68-million project will be complete by summer 2020.

“By offering more services and additional hospital beds, this expansion will help meet the needs of the growing communities of Allen and Fairview for many years to come,” said Jared Shelton, FACHE, president of Texas Health Allen. “We are committed to improving the health of people right here in the Allen area – where they work, live and play. They don’t have to go down the highway for clinical excellence and a top-level experience.”

The project will add a new patient care tower with a new perioperative space, two state-of-the-art operating suites, a second cardiac catheterization lab, a new pharmacy and additional conference space. In all, the new three-story structure will add more than 108,000 square feet of space to the hospital.

“As we continue to increase inpatient and outpatient accessibility and expand our physician network to accommodate the growth in the North Texas population, it’s important that we improve our hospitals to meet consumer expectations,” said Kirk King, Hospital Channel chief operating officer for Texas Health. “Improving our facilities means updating and expanding to meet those growing needs.”

The population of the hospital’s service area – which includes Allen, Lucas, Fairview, Frisco, Plano, McKinney, Wylie, Parker, Murphy and other surrounding Collin County cities – is already more than 425,000, with almost 90,000 new residents expected to move into the area in the next two years.

With those growth projections and population numbers, Texas Health leaders said it’s time for the hospital to undergo a major expansion. Among other specialties, orthopedics, back and spine, and cardiology services are already in high demand at the 68-bed hospital.

Another major addition to the hospital’s already robust list of service lines getting an up-

grade this year is the sports medicine facility. Texas Health Sports Medicine has joined with Athlete Training and Health, Allen Orthopedics and Sports Medicine, a Texas Health Physicians Group practice, and members of the Allen community to build a new athletics and fitness facility at Texas Health Presbyterian Hospital Allen.

The \$10 million facility brings together athletes and fitness enthusiasts from across the Collin County area where they have access to orthopedic surgeons, rehabilitation for injuries, fitness classes and athletic performance training in one convenient location.

In addition to the building, the site provides outdoor green space with pathways for pedestrians and bicyclists, an adult fitness patio and a multi-purpose turf training field for teams and local organizations.

## NEW TRAIL CONSTRUCTION



Recently the Town of Fairview received a grant from Collin County to help fund the construction of a new trail connection. This trail is an important piece of the Town’s overall trail plan as it will ultimately connect the Northern section of the commercial district to Southern section.

The trail begins at the intersection of Latham Drive and Fairview Parkway. Then goes north on Fairview Parkway and

follows the DART ROW to an existing trail behind the Sorrel Apartments. This portion of the trail is just under one mile, bringing the total length of Fairview trails to 12 miles.

To allow for the connection to the trail at Sorrel the Town worked with Lakes Engineering to design a bridge to cross over Sloan Creek. The bridge was recently placed by contractor HQS. The target completion date for the trail is mid-December (weather permitting).

The best place to access this new trail is to park in the parking lot behind Bowlero and begin at The Village Trail trailhead that takes you to the Village Green at the intersection of Latham Drive and Fairview Parkway. This portion of the trail is just under half a mile, making the trail from the trailhead to the bridge approximately 1.5 miles.





## Remember These Simple Guidelines For Putting Your Trash Out

1. Place carts on the edge of the street/alley with handles facing the house and with the lids opening to the street/alley.
2. Keep carts two to three feet apart and away from fences, cars, gates, gas meters, etc...
3. All trash should be contained in securely tied plastic bags, All bags should fit into the cart with the lid closed.
4. Do not place hazardous household waste in your cart.
5. Place your carts out by 7 a.m. on pick up day; carts should not be left out after 6 a.m. the following day.
6. Do not place any items out side your carts; unless it's for bulk pick up.
7. Brush and bulk trash must not be more than 12 cubic yards which is equal to 4 truck loads.
