#### SUBJECT: CONDITIONAL USE PERMIT FOR CHASE OAKS CHURCH FOR A WALL MURAL (CASE #CUP2023-01)

BACKGROUND: This is a request for approval of a Conditional Use Permit (CUP) for a wall mural for Chase Oaks Church. The 10.6-acre site is located at 611 Stacy Road and is zoned for the (RE-1) One-acre Ranch Estate District with a CUP for a religious facility. Applicant: Greg Holmes, Pastor of Arts and Cultural Engagement for Chase Oaks Church.

Chase Oaks Church was first granted CUP approval in 2013 for the original design and construction of the campus. Revised CUPs were then granted in 2014 (revised site, landscape and façade plans) and 2016 (revised site and landscape plans to add more parking, and a revised sign package).

#### STATUS OF ISSUE:

Per ordinance, religious facilities that are located within a residential zoning district must obtain approval of a Conditional Use Permit prior to construction. Development plans, including the site and landscape plans, building design (façade) and signage are included with that CUP request. Signage is included because the Town of Fairview Code of Ordinance does not establish sign regulations for developments of this type in residential districts. The Code of Ordinance also defines murals as a sign type, therefore, in order to add a mural to the exterior of the building, a revised CUP must be requested.

The proposed mural will be approximately 25'x25' and be located on the east wall of the existing building.


#### Public Input

## Mural Project for Chase Oaks Church, Sloan Creek Campus in Fairview

Purpose of the Sloan Creek Campus mural project

- To beautify our Sloan Creek Campus and be a beautiful addition to the City of Fairview. (The wall we are looking to address can be seen by west-bound traffic on Stacy.)
- Celebrate the broader community that surrounds our campus. This mural is not about Chase Oaks. We want for our city to be proud of this mural for the diverse population of our community to feel honored.

#### Sloan Creek Campus wall for mural





- Far left portion of exterior east facing wall that houses the church office and one of our KidsCo rooms. The wall faces the parking lot and would be visible to west-bound traffic on Stacy Rd.
  - The mural would span the entire height of the wall (25ft) and would be approximately 25ft wide.
  - Some of the far-left portions of the design would wrap around the corner slightly onto adjacent, south-facing wall.
  - Two of the shrubs that are now blocking a portion of the wall would be removed to provide visibility.

As our artists have spent time with Chase Oaks Church and learned about the communities surrounding our Sloan Creek Campus, they have chosen three themes to inform their image:


- Family So many people move out to this area to have a bit more room for their family. Children and family are huge priorities for just about everyone in our area. We want to celebrate that.


