Description

The Town of Fairview is accepting applications for the position of Building Official. The position, which reports to the Town Engineer, will play a key role in working with the Town Engineer to identify short and long-term operational needs of the department while fostering a working environment of inclusiveness and empowerment. The desired candidate will be a decisive leader who is willing to initiate new ideas and solutions, while remaining open to feedback and suggestions on service delivery philosophy and processes. The position is supported by a permit technician and third-party providers as needed, but will take the lead on all building inspections within the Town. The position is responsible for performing on-site plumbing, electrical, mechanical, energy, zoning, accessibility and other code related inspections on a wide range of residential, commercial, office and retail developments; plan review; and providing building code information to the general public. The Building Official also plays a leading role in educating community stakeholders (builders, contractors, town staff, etc.) about the critical function of building codes and best practices. This position also coordinates with the Fire Marshal and fire inspections.

This is an outstanding opportunity for a progressive building official to work with a fiscally stable community and make a difference. The Building Official should be committed to continuing and expanding current building service enhancement initiatives and have a combination of education and background that enables him/her to pursue this objective.

Requirements:

High school diploma or General Education Degree (GED), five (5) or more years of relevant building inspections experience including plan review and inspections and two (2) years supervisory experience OR equivalent combination of education, training and experience.

Licenses and Certifications:

- Valid Texas Department of Public Safety Driver's License.
- Plumbing Inspector's license issued by the Texas State Board of Plumbing Examiners.
- Commercial Building Inspector/Plans Examiner (ICC-BUI).
- CBO certification by the ICC or obtain in the first six months of employment.

- Town organization, operations, policies and procedures.
- Principles and practices of building construction and building trades.
- Federal, state, and local building codes and regulations.
- Planning and zoning ordinances and regulations.
- Methods, procedures, and standards for maintaining municipal building inspection records.
- Supervisory practices and procedures
- Plan review requirements
- Work safety practices
