

ORDINANCE NO. 2018-24

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF FAIRVIEW, TEXAS, REPEALING ORDINANCE 2011-9-6B AS AMENDED BY ORDINANCE 2012-7-3B, AND AS MAY HAVE OTHERWISE AMENDED, AND ABOLISHING THE ENVIRONMENTAL MANAGEMENT ADVISORY COMMITTEE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Fairview Town Council has from time to time established various town boards, commissions, and committees; and

WHEREAS, the Fairview Town Council previously adopted Ordinance 2011-9-6B creating the Environmental Management Advisory Committee (“Environmental Committee”), which was later amended by adopted Ordinance 2012-7-3B; and

WHEREAS, the Fairview Town Council recognizes and appreciates the diligent service and assistance of all current and former members of the Environmental Committee; and

WHEREAS, the Environmental Committee was intended to serve as a purely advisory body, but is no longer necessary for the purposes of investigating and reporting on environment plans, projects, regulations, guidelines, or related activities; and

WHEREAS, the Fairview Town Council hereby deems it in the best interest of the citizens of the Town of Fairview to repeal Ordinance 2011-9-6B creating the Environmental Committee, which was later amended by adopted Ordinance 2012-7-3B, and as may have otherwise amended; and


NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FAIRVIEW, TEXAS:

- Section 1.** That Ordinance 2011-9-6B as amended by Ordinance 2012-7-3B, as may have been otherwise amended, are hereby repealed in their entirety; and Resolution No. 2007-94-F and Resolution 2010-7-6R, as may have been respectively amended are hereby repealed in their entirety.
- Section 2.** The Environmental Committee is abolished and Division 5 (Environmental Management Advisory Committee) of Article 1.06 (Boards and Commissions) of Chapter 1 (General Provisions) of the Code of Ordinances, Town of Fairview, Texas (“Code”), is repealed in its entirety and shall be removed from the Code. The repeal of said Division 5 of Article 1.06 extends to any and all prior amendments to that article and its constituent sections and subsections.
- Section 3.** That the sections, paragraphs, sentences, phrases, clauses and words of this ordinance are severable, and if any section, paragraph, sentence, phrase, clause or word in this ordinance or application thereof to any person, firm or corporation, or to any circumstance is held invalid or unconstitutional by a Court of competent jurisdiction,

such holding shall not affect the validity of the remaining portions of this ordinance, and the Fairview Town Council hereby declares that it would have adopted such remaining portions of this ordinance despite such invalidity, which remaining portions shall remain in full force and effect.


Section 4. That this ordinance shall take effect immediately upon passage or after passage and publication if required by law, and it is accordingly so ordained.
