ORDINANCE NO. 2023-13

AN ORDINANCE OF THE TOWN OF FAIRVIEW, TEXAS, AMENDING CHAPTER 4 (BUSINESS REGULATIONS), ARTICLE 4.02 (ALCOHOLIC BEVERAGES) OF THE FAIRVIEW CODE OF ORDINANCES BY AMENDING CERTAIN DEFINITIONS AND PROVISIONS RELATING TO THE REGULATION OF ALCOHOLIC BEVERAGES; PROVIDING FOR REPEALING, SAVINGS AND SEVERABILITY CLAUSES; PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE; AND PROVIDING FOR THE PUBLICATION OF THE CAPTION HEREOF.

WHEREAS, the Town of Fairview, Texas, has in the past adopted regulations related to the sale of alcoholic beverages; and

WHEREAS, the Texas Legislature has amended certain provisions and definitions in the Texas Alcoholic Beverage Code and it is the intent of the Town Council for this ordinance to amend the Town's regulations pertaining to the sale of alcoholic beverages to be consistent with state law;

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FAIRVIEW, TEXAS:

<u>SECTION 1. Findings Incorporated.</u> The findings and recitals set forth above are incorporated into the body of this ordinance as if fully set forth herein.

<u>SECTION 2. Amendment of Section 4.02.002 (Definitions).</u> Section 4.02.002 (Definitions) of the Fairview Code of Ordinances is hereby repealed in its entirety and replaced with the following:

§ 4.02.002 **Definitions**. ■

To the extent that words or phrases used in this article are defined in the Texas Alcoholic Beverage Code, such words or phrases shall have those same definitions. All other words or phrases shall be defined according to their ordinary meaning, unless specified otherwise in this section.

<u>Beer.</u> Any "malt liquor" as that term is defined in the Texas Alcoholic Beverage Code.

<u>Home brewer and vintner.</u> A person who prepares, brews, or otherwise makes any wine or beer on his or her residential property for personal home consumption only, and not for sale for any purpose.

<u>Off-premises</u>. Locations other than those described in the definition of "premises", below.

<u>Permittee.</u> A person who is the holder of a permit provided for in the Texas Alcoholic Beverage Code, or an agent, servant, or employee of that person.

<u>Premises.</u> The grounds and all buildings, vehicles, and appurtenances pertaining to the grounds, including any adjacent premises if they are directly or indirectly under the control of the same person.

SECTION 3. Amendment of Section 4.02.003 (Hours of operation). Section 4.02.003 (Hours of operation) of the Fairview Code of Ordinances is hereby amended as follows:

§ 4.02.003 Hours of operation.

This section providing hours of operation applies only as permitted pursuant to section 105.03(c) and (d) of the Texas Alcoholic Beverage Code (the code). All mixed beverage permittees shall have a valid mixed beverage retailers late hours certificate permit as required by section 29.01 of the code in order to sell and offer for sale mixed beverage between midnight and 2:00 a.m. on any day.

<u>SECTION 4. Amendment of Section 4.02.004 (Location of businesses).</u> Section 4.02.004 (Location of businesses) of the Fairview Code of Ordinances is hereby amended as follows:

§ 4.02.004 Location of businesses.

(a) Retail businesses engaged in sale of <u>alcoholic beverages (including without limitation</u> beer and wine) for off premises consumption only. The sale of <u>alcoholic beverages (including without limitation</u> beer and wine) is permitted only in a zoning district where retail sales are allowed and not in any single-family residential area. The minimum distance between retail stores that offer the sale of beer and wine for off-premises consumption and the following uses are:

- (1) Schools (public and private): 300 feet. All measurements of distances are as provided for in state law (property line to property line and in a direct line across intersections). Day-cares are not included in the definition of schools.
- (2) Churches: 300 feet. All measurements of distances are as provided for in state law (along the property lines of the street fronts and from front door to front door, and in a direct line across intersections).
- (3) Hospitals: 300 feet. All measurements of distances are as provided for in state law (along the property lines of the street fronts and from front door to front door, and in a direct line across intersections).
- (b) Restaurants issued food and beverage certificate selling mixed beverages for on-premises consumption only. The sale of mixed beverages in a restaurant by food and beverage certificate holders is allowed in any zoning district where restaurants are allowed. The holder of a permit under this subsection shall not be required to meet distance requirements as set forth in subsection (a) above.

SECTION 5. Amendment of Section 4.02.032 (Application fee; initial permit fee). Section 4.02.032 (Application fee; initial permit fee) of the Fairview Code of Ordinances is hereby amended as follows:

§ 4.02.032 Permit fees Application fee; initial permit fee.

- (a) An application fee in the amount of \$75.00 shall be charged by the town secretary for accepting any initial permit application. No permit application may be accepted unless accompanied by the application fee. The town initial permit fee shall be equal to one-half of the state fee required by the state alcoholic beverage commission of every person that may be issued any state permit or license for the manufacture, distilling, brewing, importing, transporting, storing, distributing or sale of any alcoholic beer, wine or mixed beverage, unless a different fee is allowed or required by state law. No town permit may be issued unless the initial permit fee is received.
- (b) Notwithstanding subsection (a), above, or any other provision of this article, the initial permit fee for a mixed beverage permit shall not be charged and permit renewal fees for a mixed beverage permit shall not be charged during the three-year period following the issuance of the initial permit.
- (c) The town secretary shall issue a receipt for the application fee and initial permit fee and keep a record of the same in the town secretary's office.

(d) Subject to the exception for a mixed beverage permit stated in subsection (b), above, a person who sells an alcoholic beverage without first having paid an applicable permit fee under this section commits a misdemeanor punishable by a fine of up to \$200.00, with each day of such violation being a separate offense.

SECTION 6. Amendment of Section 4.02.033 (Renewal; renewal fee). Section 4.02.033 (Renewal; renewal fee) of the Fairview Code of Ordinances is hereby amended as follows:

§ 4.02.033 Renewal; renewal fee.

- (a) All town-issued permits shall be renewed annually. All permits shall terminate at midnight on the day before the anniversary date of their issuance, and no permit shall be issued covering a term longer than one year.
- (b) The town shall require payment of an annual permit renewal fee by all establishments selling alcoholic beverages within the town. The permit renewal fee shall be equal to one-half of the state fee required by the state alcoholic beverage commission of every person that may be issued any state permit or license for the manufacture, distilling, brewing, importing, transporting, storing, distributing or sale of any alcoholic beer, wine or mixed beverage, unless a different fee is allowed or required by state law. Notwithstanding the foregoing or any other provision of this article, the permit renewal fee for a mixed beverage permit shall not be charged during the three-year period following the issuance of the initial permit.
- (c) The town secretary may cancel a permit if a permittee fails to pay the permit renewal fee. The town secretary shall send notice of such cancellation to the address on file with the permit application.
- (d) Subject to the exception for a mixed beverage permit stated in subsection (b), above, a A-permittee who sells an alcoholic beverage without first having paid the permit renewal fee under this section commits a misdemeanor punishable by a fine of up to \$200.00, with each day of such violation being a separate offense.

SECTION 7. Savings/Severability/Repealing Clause/Penalty. All ordinances and provisions of the Code of Ordinances, Town of Fairview, Texas in conflict with the provisions of this ordinance are repealed to the extent of that conflict. If any provision of this ordinance shall be held to be invalid or unconstitutional, the remainder of such ordinance shall continue in full force and effect the same as if such invalid or unconstitutional provision had never been a part hereof. The Town declares that it would have passed this ordinance, and each section, subsection, sentence, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional or invalid. It shall be a Class C

misdemeanor to violate any provision of this ordinance or the regulations adopted hereunder. The amount to be paid upon conviction shall not exceed the amount set forth and as applicable in the Fairview Code or in said regulations, or the highest amount allowed by law, whichever is lower. Each day such violation shall continue, or be permitted to continue, shall be deemed a separate offense.

<u>SECTION 8</u>. <u>Effective Date</u>. This Ordinance shall be effective immediately upon its passage and publication as required by law.


