

## **Residential Washing Machine Rebate Program**

In order to encourage the conservation of water, specifically through reduction of water used for residential clothes washing, the Town of Fairview has adopted a rebate program for water-efficient clothes washing machines.

To be eligible, a resident must have an active and up-to-date Town of Fairview residential water utility account.

The program started on May 4, 2005; therefore, only approved washing machines purchased on or after that date will be eligible for a rebate.

Only new, qualifying models of washing machines will be eligible for rebate. A new high water-efficient washing machine must replace a low water-efficient washing machine. A list of qualifying washing machines can be found online at <http://www.cee1.org/resid/seha/rwsh/rwsh-prod.pdf>.

Applications must be received within 120 days of purchase, and must be submitted on an official completed town rebate form.

All rebates are subject to the availability of funds during any given fiscal year. Requests will be processed and funded on a first-come, first-served basis.

Approved rebates shall be given in the form of a credit to the applicant's water utility account.

Rebates will be in an amount equal to the purchase price or \$50.00, whichever is less.

No more than one washing machine rebates per physical address shall be granted.

## Residential Washing Machine Rebate Form

Getting your washing machine rebate is easy. Simply select, purchase and install a water efficient washing machine from the qualifying list. Then, complete and mail (or drop off) this rebate application form, along with original copies of your receipt and proof of purchase. A town representative will visit your site within about thirty days to ensure the machine is properly installed and functioning. If approved, your rebate, up to \$50.00, will show up as a credit on your water utility bill.

I understand that an incomplete application will result in a rebate delay.

I acknowledge that the town is in no way responsible for the condition of the plumbing on my side of the meter, now or in the future.
