1. Call to order.
2. Town Council recesses into executive session.

The Town Council will meet in closed session regarding the following items and/or any item posted on the agenda notice for this meeting as necessary under the following exceptions to the Open Meetings Act under Texas Government Code:

Section 551.071 – to consult with legal counsel regarding pending or contemplated litigation and/or on matters in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code.

Section 551.074 Personnel- including – all non-advisory boards and commissions.

Section 551.087 Economic Development - including business prospects in the CPDD.

The council further reserves the right to enter into executive session at any time throughout any duly noticed meeting under any applicable exception to the Open Meetings Act.

3. Town Council reconvenes into regular session and may consider and take action as appropriate on any executive session item. (*approximately 7:30 p.m.*)

5. Appointments.

  - b. Hear Annual Update from Allied Waste including recommendations for changes in bulk pickup schedule and the annual CPI increase and take any necessary action.

6. Consent agenda.

- c. Approve minutes of the June 5, 2014 joint council meeting.
- d. Approve minutes of the June 5, 2014 special joint council meeting.
- e. Approve a Resolution authorizing payment of dues for continuing membership with the Atmos Cities Steering Committee.

7. Site Plans and Plats

- a. Discuss and consider approval of a Final Plat for a two lot residential subdivision on a 5.00± acre tract that is situated in the Calvin Boles Survey - Abs. No. 28 and zoned Two-Acre-Ranch-Estate (RE-2), and is generally located north of Stacy Road and 2,500 feet west of Orr Road.

- b. Discuss and consider approval to adopt an Ordinance repealing and replacing Article 13.07 "Water Conservation Plan" and adopting a new Water Conservation Plan, a Water Resource and Emergency Management Plan, and Procedures for Enforcing Mandatory Water Use Restrictions.
- c. Discuss and consider the draft 2014 Strategic Plan and take any necessary action.
- d. Discuss the Event Committee report, review proposed ordinance establishing a standing event committee and take any necessary action.

10. Receive reports from Staff, including any updates, monthly financial report.

Receive reports from staff or the Town Council about items of community interest. *Items of community interest include: expressions of thanks, congratulations, or condolence; information regarding holiday schedules; an honorary or salutary recognition of a public official, public employee, or other citizen (but not including a change in status of a person's public office or public employment); a reminder about an upcoming event organized or sponsored by the governing body; information regarding a social, ceremonial, or*

*community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the municipality; and announcements involving an imminent threat to the public health and safety of people in the municipality that has arisen after the posting of the agenda.”*
