


SCRAMBLE FOR SOLDIERS

NATIONAL TAKE BACK INITIATIVE

On October 26, 2013 from 10am-2pm, the Fairview Police Department in coordination with the DEA will host National Pharmaceutical Take Back Initiative. Residents will be able to drop off expired, unwanted, or unused pharmaceutical controlled substances, and other medications at the drop-off location, which will be at Fire Station #1, 500 S. State Hwy 5. Residents may dispose of medication in its original container or by removing the medication from its container and disposing of it directly into the disposal box.



Liquid products, such as cough syrup, should remain sealed in their original container. It is also important to note that your information will be kept completely anonymous. TOWN REBATES



Want to lower your water bill and help promote water conservation? The Town of Fairview can help you ease the burden of doing so through its water conservation rebate programs!

The Town offers four different rebates for water-saving devices that residents purchase and install at their residences. Please note that rebates are only offered for the purchase and installation of retrofitted devices that are not already present at a residence. All rebate approvals require the filling out of an application, as well as original invoice(s) showing proof of device purchase and, in the case of the Residential Pressure Reduction Rebate and Rain and Freeze Rebate Sensor Programs, installation costs.

To access the rebate applications and for more complete information on these four rebates, please visit www.fairviewtexas.org, hover over the “Other Pages” drop down menu, click on the “I Want To” tab, and then scroll down to “Get a Rebate Form”. The four rebates are summarized below:

Residential Pressure Reduction Rebate Program

- A rebate for the purchase and installation of a water pressure reduction device on water systems with current pressures of 90 psi or higher.
- The rebate will be in an amount equal to the purchase price or \$150, whichever is less.

Residential Rain Barrel Rebate Program

- A rebate for the purchase of up to two rain barrels installed and used on residential properties.
- The rebate will be in an amount equal to the purchase price or \$50, whichever is less.

Residential Rain and Freeze Sensor Rebate Program

- A rebate for the purchase and installation of a sensor that helps to shut off irrigation systems during periods of inclement weather when irrigation is unnecessary and wasteful.
- The rebate will include the price of a qualifying rain and freeze sensor, installation hardware, and installation costs incurred by a licensed irrigator up to a maximum of \$50 per residential utility account.

Residential Washing Machine Rebate Program

- A rebate for the purchase of a water-efficient washing machine.
- The rebate will be in an amount equal to the purchase price or \$50, whichever is less.

PUBLIC HEARINGS

Notice is hereby given that the Fairview Planning and Zoning Commission will meet on Thursday, October 10, 2013 beginning at 7:00 p.m. at Town Hall, located at 372 Town Place in Fairview.

- Continue a public hearing, consider, and take any necessary action on a request for approval of a Conditional Use Permit in order to allow for an accessory building on a property that is zoned Planned Center (PC) and is specifically located at 1011 Young Trail, being Lot 12 of the Collinwood Acres subdivision. **(ZA2013-23)**
- Conduct a public hearing, consider, and take any necessary action on a request for approval of a Conditional Use Permit (CUP) in order to allow for an accessory building on a property that is zoned One-Acre Ranch Estate (RE-1) and is specifically located at 261 Wyndham Court, being Lot 14, Block 3 of the Summer Hill Farms subdivision. **(ZA2013-26)**
- Conduct a public hearing, consider, and take any necessary action on a request for approval of a Conditional Use Permit (CUP) in order to allow for a religious institution on a 10.672± acre property located within the John A. Taylor Survey - ABS No. 909, that is zoned One-Acre Ranch Estate (RE-1) and is generally located north of Stacy Road and 1,400 feet west of Meandering Way. **(ZA2013-27)**
- Conduct a public hearing, consider, and take any necessary action on a request to amend the land use designation and zoning for Lot 4 of the Country Club Estates subdivision, a 2.85± acre lot which is currently zoned Two-Acre Ranch Estate (RE-2) and categorized as Residential Estate Country (REC) on the Future Land Use Plan, and generally located at the southeast corner of Country Club Road (FM 1378) and Red Oak Trail; to the Residential Estate (RE) land use designation and the One-Acre Ranch Estate (RE-1) Zoning District, generally, in order to add an additional single-family residential lot. **(ZA2013-28)**
