

## **Residential Pressure Reduction Rebate Program**

In order to encourage the conservation of water and to reduce run-off, specifically through the reduction of water pressures that contribute to over-irrigating, the Town of Fairview has adopted a rebate program for pressure reduction devices installed and utilized on certain residential properties.

To be eligible, a resident must have an active and up-to-date Town of Fairview residential utility account.

The program starts on June 5, 2007; therefore, only approved pressure reduction devices purchased on or after that date will be eligible for a rebate.

Initial water pressures must be 90 psi or higher.

Applications must be received within 120 days of purchase, and must be submitted on an official completed town rebate form.

All rebates are subject to the availability of funds during any given fiscal year. Requests will be processed and funded on a first-come, first-served basis.

Approved rebates shall be given in the form of a credit to the applicant's water utility account.

Rebates will be in an amount equal to the purchase price or \$150.00, whichever is less.

## Residential Pressure Reduction Rebate Form

Getting your pressure reduction rebate is easy. Simply hire a licensed plumber to test your water pressure, and if it is more than 90 psi, have him install a water pressure reduction device. Then, complete and mail (or drop off) this rebate application form, along with original copies of your receipt and proof of purchase. A town representative will visit your site within about thirty days to ensure the device is properly installed and functioning. If approved, your rebate, up to \$150.00, will show up as a credit on your water bill.
